5:30 PM - Announcements - Barbara Welder calls meeting to order, recognizes cottage developer Gordon Awsumb. Erik Engen introduces City Council Dist 1 candidate Tracy McCall.

Treasurer's Report - Michael reports balance of \$1,128.20 (+ \$2,000 Dolphin Park donations, \$5,220 History Plaza donations)

Minutes April 2021 - Printed minutes included in meeting packet. Carrie makes a motion, it's seconded and membership approves minutes.

5:35 PM - OLD BUSINESS

North Beach History Plaza Signs have been installed, sidewalk painted with colorful "trail" beside signs, 2 planters, 3 benches, trash can. City cut shade structure funding from 2023 budget, but it may get paid for in future years. Carrie contacted the city about staging a ribbon cutting.

Bond 2018 street projects Good news: Beach Ave and Gulfspray Ave are going to be rebuilt. City said in "mid-2023".

Bond 2020 - Surfside Park - Carrie gives update from ACM Neiman Young: the city is updating its design on the 2 streets near the park with plans to start construction within 90-120 days (~early 2023)

Bond 2022 - This will be on the Nov 8th ballot - North Beach Eco Park (\$100,000 for engineering) + \$3 million to rebuild 3 blocks of Surfside Blvd near the DoubleTree Hotel (formerly The Radisson)

Beach Nourishment – Carrie reports that the GLO says they are starting the beach nourishment this fall **Breakwater Islands** – Judge Barbara Canales has applied for funding; Carrie attended Public Input meeting at Council of Governments in Sinton on Aug 24 with Peter Davidson (Ed Rachel Foundation) to speak in favor of the breakwater projet.

ADJOURN MEETING

6:00 PM - SPEAKER - Robert Dodd, Director of City of CC Parks & Rec Dept

Mr. Dodd worked as a coach and teacher at Ray High School for many years. Working for the city is a new career for him.

2023 Budget - City Council cut 2 North Beach parks projects- History Plaza shade + Vendor Incentive Program. Dodd says that the proposed vendor incentive program would not give money to individual vendors but would help pay for setting up a stage or bleachers for events. Barbara suggested that the History Plaza could be used as a venue for events.

Committee - Dolores asks how the city got the idea to add vendors and lifeguards (for example) on North Beach. Who do they talk to on North Beach to make those decisions, because none of us were contacted? Dodd doesn't know. Carrie brings up NBCA's suggestion of the city forming an official committee for North Beach representatives from hotels, businesses, attractions and residents that the city could then come to to present ideas for improvements as a way to vet those ideas across the community.

Surfside Park - Dodd said "Peter Zanoni has made it a mission to revitalize this area."

North End - Gordon Aswaub who is building on 4600 block of Gulfbreeze said that the bathhouse at Dolphin Park is dirty and the whole area up there needs attention. Dodd said he will deal with bathhouse cleanliness but other improvements take time. Carrie said that the **Bond 2022 Eco Park** proposal would improve the entire 25 acres between the beach and the wetlands, if it gets voter approval on Nov 8.

Tracy McCall suggested we talk to **Parks & Rec Advisory Committee**, that PRAC member Kelly Summers is a North Beach advocate. Work with PRAC to get support. Carrie served on PRAC for 6 years, then Watershore & Beach Advisory Committee (WBAC) for another 6. Both impact North Beach.
