### I. OBJECTS OF THE CLUB

The objects of this club shall be: To promote training for dogs by their owners under the supervision of qualified trainers; to hold sanctioned matches and obedience trials under the Regulations of the American Kennel Club, and to educate the public in the value of the well trained dog.

### II. CONDITIONS

1. Application for training must be made on this form, supplied by the Club for this purpose and must be accompanied by a Registration Fee and a Training Fee.
2. Application for training may be made by any person, 16 years of age or older.
3. Applicant must attend an Orientation Class.
4. Applicant must furnish a Health Certificate stating current evidence of vaccination against rabies, distemper, and parvo virus. It is also required that a stool sample be found 'Negative' for intestinal parasites. Should a person continue to train with the Club, a new current Health Certificate must be presented at the start of each training year in September. A TITER test result showing satisfactory Titer levels for DHLPP will be accepted.
5. No dogs shall be exercised on Park District property. Owners found responsible for breaking this rule shall be subject to dismissal from all further training sessions and may be further subject to an additional fine from the Police Department. Owners are required to provide clean up material for their dogs.
6. Bitches in season shall be excluded from all classes. However, owners are expected to attend class without the dog for the training program.
7. The Director of Training shall have complete charge of all trainers and training classes and shall act to assure safety to the participants and their dogs during class hours. He shall have the right to cause any person to remove their dog from class if, in his judgment, the best interests of other participants will be assured thereby.

### III. MEMBERSHIP

1. Completion of this application does not constitute application for Membership.
2. Only those persons, 16 years of age or older, may be elected to Membership.
3. Election to membership in the club can occur only after the applicant has completed two (2) training sessions and has attended one Orientation class.
4. Election to Membership shall be effected by the Executive Board in accordance with the By-Laws of the Club.
5. Upon election to Membership, applicants shall pay current membership dues in accordance with the By-Laws of the Club
