Turn right on Wichman Rd. and follow to parking lot. For GPS use 5125 Trillium, Hoffman Estates, IL 60010. Wichman Rd. is across from Trillium.

**EXHIBITORS PLEASE NOTE:**

In accordance with AKC Regulations, entries in this tracking test will be accepted up until the official closing date and time, even though the advertised limit has been reached.

A drawing will be held at the home of the test secretary, 1081 Annandale Drive, Elgin, IL on Thursday, September 16, 2021, at 6:00 p.m. to determine which entries will participate in the test. The drawing is open to the public.

This drawing, conducted by the test secretary, shall be completely at random from among the entries received, except that preference shall be given to those entries which have not earned a TDX title. The **test worker draw option**, as allowed by the AKC Tracking Regulations, Chapter 1, Section 17d, will be used in this test for club members and other workers as defined by the club's Board of Directors published in the club minutes and newsletter. There will be 1 TD and 1 TDX track set aside for workers at this test.

When the advertised limit has been drawn, all remaining entries shall be similarly drawn and assigned a position on the alternate list, subject to the same preferences set forth above.

The test secretary shall notify all entries of the result of the drawing. Alternates have the option to accept or decline being placed on the alternate list. Those who opt to decline shall have their entry fees returned upon written notification to the test secretary of their intention to withdraw from the alternate list.

In the event an accepted entry cancels after the closing of entries, the test secretary shall contact alternates in the order of their placement on the alternate list. Upon such notification, alternates shall have the option to accept or decline the opportunity to participate in the test.

No entry fee will be refunded except that of an alternate who does not participate in the test. Exception: In the event that an accepted entry withdraws from the test and an alternate replaces that entry, refund will be made to the withdrawn entry.

**ENTRY FEE WILL NOT BE REFUNDED** in the event of errors or if a dog is withdrawn from the test after the closing date, absent on the day of the test, disqualified, excused by judges or barred from competition by the test committee, unless an alternate exhibitor is available and willing to take the spot of the exhibitor. If, because of storms or other acts beyond the control of management, it is impossible to open or complete this event, no refund of entry fees will be made.

In the event an accepted entry is absent on the day of the test, it shall be the responsibility of the test secretary to determine if alternates are present, and to determine, by their position on the alternate list, which of the alternates will participate.

Rand Park DTC reserves the right to cancel the test due to extreme weather conditions.

Dogs must be on lead at all times in any area of the tracking site.

The assignment of dogs to the tracks is the responsibility of the judges.
