My name is Brad Henderson. I grew up on our family's cattle ranch – still in operation – with hands-on training from a long line of true Western Cowboys. Horses, cattle, dirt, diesel, concrete, and steel were what I cut my teeth on. I was taught to adhere to these best practices: transparency, careful advance planning, high early effort, attention to detail, and a firm hand on time and cost budget commitments. I have been in the real estate development and construction business my entire life (my father was a commercial design/builder and developer in Colorado

Springs, Colorado since the early 1960's). I was raised working with each of my Dad's subcontractors learning their trades and received a degree in Construction Management from Colorado State University in 1990. During my last summer at CSU I completed an internship with MA Mortenson as Field Engineer on the Palmer Center in Colorado Springs and fell in love with large scale commercial building. Upon graduation I was hired by Charles Pankow Builders in Altadena, CA and they moved me to Honolulu, HI as a Field Engineer where I worked on the preconstruction and construction of the majestic 40 story cast in place post tensioned concrete project Waikiki Landmark at the entrance to Waikiki then Assistant Superintendent on the 25 story cast in place post tensioned concrete luxury condominium project Nuuanu Parkside in the Nuuanu Valley, where we perfected a 3 day cycle per floor, which was unherd of at the time. Upon completion of this project, MA Mortenson hired me as General Foreman on their new Harborcourt Project in Honolulu across from Aloha Tower. As General Foreman I was responsible for all of the concrete structure which was self performed by Mortenson, including mat foundation (finish floor of mat over 20 ft below sea level- ocean just 100 feet away), jump forms for multiple elevator shafts, pour down columns, and post-tensioned slabs using fly tables. Upon completion of the structure my wife and family were yearning for us to come back home to Colorado. Where I started my own General Contracting, excavation, and trucking business. After a few years of doing all over lot grading and structural excavation for one developer in particular they hired me to become their Director of Development. I accepted the position due to me missing project management and phased out of my own business. As Director of Development I initiated all client negotiations, handled marketing for the development arm of the firm and managed all design, entitlement, and building of their projects. I learned that I have a passion for marketing and working a project from conception through to handing our clients the keys. SecurCare Development sold its holdings and I began researching the opportunities of Airport Development. I was fascinated by the fact that the Airport Request for Proposal process creates a market barrier for immediate

competition for space. I was one of the founding members of Aviation Development Group LLC. Together with my partners we completed aircraft hangar developments in Steamboat Springs, Colorado, Palm Springs, California and in Chino, California before the construction lending environment for commercial leased property became too cumbersome. All of our condominium hangars were sold within a month prior to Certificate of Occupancy. I was responsible for all sales marketing, lead acquisition, design, entitlement (local, state, and federal), and construction. After the Chino project I moved back to Colorado and began work with Lantz-Boggio Architects in Denver, CO as a Project Manager and Director of Field Operations. It was wonderful to get back into the field and work directly on site with superintendents and closely with a varied clientele. I was the Project Manager for the firm on the new Elbert County Public Health facility in Kiowa, Colorado, the new 21,000sf assisted living center Larchwood Inn in Grand Junction, Colorado, and several school and assisted living remodels across Colorado. I managed the

superintendents and subcontractors on a new Veterinary Hospital in Denver, a new credit union in Aurora (see CEO's recommendation attached), a new school in Edison, and the remodel of an ice arena in an old B-52 hangar at the old Lowry Air Force Base. Work in Denver was slowing down at that time and the oil field of West Texas called. I restarted my own company and began a journey designing and building facilities for oil and gas companies. I had the ability to work with everyone from the CEO's in their high-rise offices downtown Denver, Houston or Dallas to the roughnecks in the field offices, truck maintenance shops or salt water disposal wells we designed and built for them in record time. We also started serving their corporate flight departments and it wasn't long before we were back in the airport development business. We completed multiple corporate hangars with attached office space at Midland Air & Spaceport and were then called to design and build "The coolest FBO in the country" for Cutter Aviation in Colorado Springs along with their fuel farm and a 60,000 sf hangar sized to house four C-130 gunships or two Boeing 737s. I found the very best subcontractors and vendors in the area, and got everyone from the local Economic Development Group to the Mayor on board to expedite permitting and inspections. I took on



the roll of Project Manager and we completed it in record time- we started designs at the beginning of February 2017 and pulled aircraft into the completed hangar and had a grand opening ceremony on September 11, 2017 – 7 months, it was epic. 





