

Terms and Conditions

Please read these terms and conditions carefully before using Our Service.

SMS Communications and Data Usage:

By providing your mobile phone number, you consent to receive SMS messages, email, and phone calls from Zayas-Visser Agency and its affiliates, for delivering requested information such as quotes, illustrations, product details, promotions, and account notifications. Message frequency may vary. And, message and data rates may apply. You can opt out of receiving SMS messages at any time by replying STOP to any message received or by contacting us via phone at (256) 864-9411 or emailing at sady@sadyinsurancegroup.com.

We collect and process the following data related to SMS communications:

- Mobile phone number
- Message content
- Date and time of messages
- Delivery status

We will not share your mobile phone number or SMS data with third parties for their marketing purposes without your explicit consent, except as required by law. We may share this data with service providers who assist us in delivering SMS messages, but these providers are contractually obligated to protect your data. It will be for the sole purpose of putting a proposal or illustration together as requested or providing marketing information.

The types of data we collected related to SMS communications are phone numbers, messages, content, and delivery status.

Encrypted, trustworthy, and tenure platforms are used to keep your data safe. Do not disclose personal information such as Social Security Numbers or DOB.

We work very hard to ensure compliance with all applicable laws and regulations, including:

- TCPA (US): Regulates telemarketing calls and SMS messages.
- CAN-SPAM Act (US): Sets rules for commercial email and SMS messages.
- GDPR (EU): Sets strict requirements for data protection and privacy.
- Other local and international regulations.

Regular Review: Regularly review and update your T&C to reflect changes in laws, regulations, or business practices.
