- To submit registered joint development agreement executed between the developer company and the new entity for the area under proposed joint development/ marketing rights.
- 2. To submit an undertaking that the licencee/land owners shall not transfer the proposed land and shall not violate the condition of the licence.
- 3. To submit an undertaking that Base Exports Pvt. Ltd. shall be responsible for compliance of all terms and conditions of the licence and provisions of Act/ Rules and also abide by all the terms and conditions of LC-IV & Bilateral Agreement executed at the time of grant of licence.
- 4. To submit an undertaking that in case of any advertisement for the sale of component, name of the existing company must be prominently displayed by the Base Buildwell Pvt. Ltd.
- 5. A demand draft for the balance 60% of the administrative charges amounting to Rs. 16,51,765/-.

- 7. To submit an undertaking to settle all the pending/outstanding issues, if any, in respect of all the existing as well as prospective allottees.
- 8. To submit an undertaking to be liable to pay all outstanding dues on account of EDC and interest thereon, if any, in future, as directed by the Director, Town & Country Planning Department, Haryana.

- 9. To submit an indemnity bond regarding compliance of the orders of Hon'ble Supreme Court in CA No. 8977 of 2014 titled as Jai Narayan @ Jai Bhagwan and others Vs State of Haryana and final outcome of CBI investigation under process.
- The colonizer shall inform all the allottees of the Group Housing Colony of an area measuring 34.175 acres under licence no. 28 of 2008 dated 17.02.2002, 16 of 2008 dated 31.01.2008 and 44 of 2011 dated 13.05.2011 about the Joint Development Rights/ Marketing Rights through publication in the leading newspapers (Two English & One Hindi) and also on his website and give time to the allottees for giving their objections to proposed Joint Development Rights/ Marketing Rights limited to adverse effect on their rights, if any, in the office of concerned Senior Town Planner within a period of 30 days.
