 - Zero based budgeting for accountability
 - Establishing fraud, waste, and abuse reporting through third party vendors to increase transparency and accountability
 - Building a Citizen Audit Committee to engage the public in the financial processes and challenges faced by districts
- Worked with the Florida Legislature and Executive Office of the Governor to shape policy from a School Board Member's perspective:
 - Fewer, Better, Tests a movement towards accountability without overburdening districts
 - Adjusting SREF and giving districts flexibility in capital outlay uses
 - Changing standards from Common Core to BEST
 - Providing input on ESSER implementation
 - Developing alternative pathways to teacher certification and reducing impact of testing as a barrier
 - Limiting Terms of School Board Members to increase diversity of thought and temporally relevant representation on School Boards
 - Numerous issues of School Choice / Education Freedom such as the Family Empowerment Scholarship
 - Gathered existing statutes on Parental Rights into a single statute named as the Parents' Bill of Rights
- Established a program of “Legislative Town Halls” where legislators could explain their bills to School Board Members as they moved through the committee and floor. This direct two-way access was unprecedented and exceedingly helpful in crafting policy that reflected diverse viewpoints. The goal was limiting unintended consequences by the Legislature and building support at the district level.
- Developed “Bill Summaries” and “Message Points” for School Board Members to share in debate, with constituents, or when media contacted them for interviews.
