Inspiring Generosity Grants (request for proposal)

At First Christian Church (FCC) we are becoming Dedicated Disciples through Passionate Spirituality, Joyful Service and Inspiring Generosity. To that end, in 2021 we launched the Inspiring Generosity Grants (IGG), so that individuals and organizations in the Canton area might pursue a new or creative project to serve people in need. These grants positively impacted the community in the areas of education, poverty, personal care supplies and human services. This year, FCC is setting aside \$9,500 of our Ingersoll Trust Funds to facilitate this grant program. Grants can be written for any amount within the total. Grants will not be awarded for capital campaigns, building drives, political causes, annual fundraising events, or direct personnel expenses. However, any proposal that uplifts people and meets a basic human need will be carefully considered.

Individuals or organizations in the Canton area may apply for an IGG. Grants will be awarded to proposals that address a community need or support a new community service project in the Canton area. In addition to the grant, FCC members may wish to collaborate by volunteering with the proposed project.

Deadline for submission of application is October 15, 2025 and recipients will be notified in writing on the status of each grant. Grant applications can be found at www.cantonfcc.org/grants.

Be prepared to tell your story to FCC through some form of presentation, i.e. a video, a spoken presentation in worship or some other format.
