

**CITY OF ST. MARIES
RESOLUTION NO. 2025-354**

A RESOLUTION OF THE CITY OF ST. MARIES, BENEWAH COUNTY, STATE OF IDAHO, FOR AN AMENDMENT TO THE FEE SCHEDULE TO INCREASE GARBAGE RATES.

BE IT HEREBY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ST. MARIES, IDAHO:

WHEREAS, Idaho Code § 63-1311 provides, in part, that the governing board of taxing districts may collect fees for those services provided which might otherwise be funded by property tax revenues; and

WHEREAS, Idaho Code § 63-1311A provides that before approving any new fees, or a fee increase in excess of five percent (5%) the Council Members must conduct a public hearing on said proposal; and

WHEREAS, the City published notice of the public hearing in the St. Maries Gazette Record on August 13, 2025, and August 20, 2025, and in accordance with the laws of the State of Idaho; and

WHEREAS, the County garbage rates are passed directly onto the citizens of St. Maries, which is reflected in the garbage rate increase provided for herein; and

WHEREAS, after the public hearing on August 25, 2025, held prior to the adoption of this resolution, in accordance with Idaho Code § 63-1311A, regarding increased garbage fees, it is deemed by the city council to be in the best interests of the City of St. Maries and the citizens thereof that the fee schedule be amended to include the increased garbage fees.

NOW THEREFORE, BE IT RESOLVED, that the fee schedule attached hereto as Exhibit A (and fully incorporated herein), which reflects the new fee, and the existing fees that have not been amended, be adopted effective the 1st day of October, 2025.

BE IT FURTHER RESOLVED that the following new fee and amendment to the fee schedule takes effect on this 1st day of October, 2025:
