

CITY OF ST. MARIES RESOLUTION NO. 2023-330

A RESOLUTION OF THE ST. MARIES CITY COUNCIL TO PROVIDE FOR AN INCREASE IN WATER, SEWER AND GARBAGE RATES.

WHEREAS, Idaho Code 63-1311 provides, in part, that the governing board of taxing districts may collect fees for those services provided which might otherwise be funded by property tax revenues; and

AND WHEREAS, Idaho Code 63-1311A requires advertisement and hearing on fee increases by any taxing district if the fee increase is in excess of five percent (5%) of the amount of the fee last collected; and

AND WHEREAS, it is necessary periodically to adjust the fees charged for water, sewer and garbage rates provided by the City of St. Maries in order to help defray the public costs of such services; and

AND WHEREAS, the City has conducted a public hearing, duly noticed, on the proposed fee increases set forth below on Monday, August 28, 2023;

NOW, THEREFORE, BE IT RESOLVED the City Council in and for the City of St. Maries, Benewah County, Idaho, upon motion duly made and seconded, adopts the following fees, to be effective as of October 1, 2023.
