

**CITY OF ST. MARIES
RESOLUTION NO. 2026-362**

A RESOLUTION OF THE CITY OF ST. MARIES, BENEWAH COUNTY, STATE OF IDAHO, AMENDING THE CITY'S FEE SCHEDULE TO ESTABLISH A FEE FOR A SEASONAL COMMERCIAL UTILITY RATE REDUCTION FOR TEMPORARY WATER SERVICE SHUTOFFS, AND FOR PUBLIC RECORDS REQUESTS FROM NONRESIDENTS.

BE IT HEREBY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ST. MARIES, IDAHO:

WHEREAS, Idaho Code §§ 50-301, 50-701, 54-5016, 39-4116, 63-1311, 63-1311A, 74-102, and other related statutes authorize the City Council Members of St. Maries ("Council Members") to assess and collect fees for services provided by the City, and specifically, to adopt such rules or resolutions as may be necessary to carry out their duties and responsibilities; and

WHEREAS, Idaho Code § 63-1311A provides that before approving any new fees, or a fee increase in excess of five percent (5%) the Council Members must conduct a public hearing on said proposal; and

WHEREAS, the City Council finds it appropriate to adopt a Seasonal Utility Disconnect Policy permitting eligible metered commercial users to request a one temporary seasonal shutoff of water service, per year, and to establish a corresponding reduced base rate for qualifying accounts during periods in which water service is locked and unavailable for use; and

WHEREAS, the City Council finds it appropriate to approve the new fee for public records requests by nonresidents, in accordance with Idaho Code § 74-102(10); and

WHEREAS, the City published notice of the public hearing in the St. Maries Gazette Record on June 10, 2026, and June 17, 2026, and in accordance with the laws of the State of Idaho; and

WHEREAS, the Mayor has recommended the following amendments to the fee schedule for City services to the Council Members for adoption, by resolution, and the Council Members have examined the fee schedule and have determined that the fees set forth in the schedule are appropriate, and reasonably related to, but do not exceed, the actual cost of the services to be provided by the City; and

WHEREAS, after the public hearing on June 22, 2026, held prior to the adoption of this resolution, in accordance with Idaho Code § 63-1311A, regarding new, increased and changed city fees, it is deemed by the city council to be in the best interests of the City of St. Maries and the citizens thereof that the fee schedule be amended to include the new fees which were addressed in the public hearing.

NOW THEREFORE, BE IT RESOLVED, that the fee schedule attached hereto as Exhibit A (and fully incorporated herein), which reflects the new fees, and the existing fees that have not been amended, be adopted effective the 22ND day of June, 2026.

BE IT FURTHER RESOLVED that the following new fee and amendment to the fee schedule takes effect on this 22ND day of June, 2026:

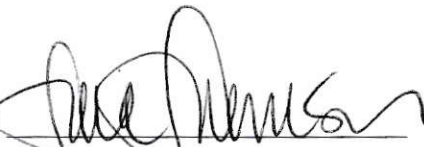
