1. Call to Order.

The regular meeting of the St. Maries City Council was called to order by Mayor Tom Carver at 5:30 p.m. on Monday, September 22, 2025, in Council Chambers at City Hall, 602 College Avenue, St. Maries, Idaho.

- b. **Public Hearing; Proposed Amended Budget for FY24/25 (Ordinance No. 2025-786). – action item**

Mayor, Tom Carver, explained the order and procedure of the public hearing. Jaidyn Kinzer, City Clerk, gave a staff introduction to the proposed amended budget for fiscal year 2024-2025. The public hearing was open at 5:35 PM. There were no written comments. There was no testimony being in favor of, neutral, or in opposition to the proposed amended budget for fiscal year 2024-2025. The public hearing was closed at 5:36 PM.

d. **Area of Impact Map. – action item**

Tyler Kuber, with HMM Engineering, explained that the Planning Commission has been working on updating the Area of Impact map for the City and have provided two options for the Council to review. Kuber states that based on the Idaho Code criteria for updating the map, the map includes areas within a 2-mile radius from the City Limits, has the possibility of being annexed, and properties that may have city water services. The second map version is the same as the first but it includes additional parcels in section 13 near Bells Lake.

Shiloh Pfeiffer, Public Works Director, stated sidewalk panels on College Avenue have been repaired. Pfeiffer also stated the crew is going to begin prepping certain areas for winter.

d. **Police Update.**

Scott Castles, Police Chief, commented that the police department will be updating their schedule due to the weather changing.

e. **Building Official Update.**

Jacob Parsons, Building Official, stated that the approval for the HUD housing program is still under review by DOPL. Parsons also stated that the State is currently looking into the adoption of the 2024 building code.

8. **Public Comments**

Mayor Carver recited the rules and procedures for public comment, followed by an opportunity for comments from the public regarding items included on the agenda and other topics relevant to the business of the City of St. Maries. Information only; no Council action.

Jerry Parmaley, mayor candidate, introduced himself to the City Council and shared background and job experience.

The Executive Session ended, and the regular session was reconvened at 6:15 PM.


10. Adjourn.
