- Delivery and set up fees are included in total invoice.
- We are not responsible for any damage to any desserts after set up is done. You are responsible for providing appropriate and secure tables and environment for your desserts.
- Optional room temperature of 70 degrees and below. This temperature will help keep desserts cool.
- If you or your representative decide to pick up the desserts and set up, you assume all liability and responsibility for the condition of the desserts once you pick them up.
- On occasion, we will photograph our desserts, and we reserve the right to use any photographs for display or promotion without compensation to you.
- Our products may contain or come into contact with milk, wheat, nuts, soy and other allergens. You agree to notify your guest of this risk and hold us harmless from allergic reactions.
- Local delivery and set up is \$50. Outside of the 10-mile radius, we can deliver and set up for a fee of \$0.75 per mile round trip.
