Dear Parents & Guardians:

The first five years of a child's life are filled with incredible growth and development. Your child is changing daily: constantly learning new words, mastering new skills, and grasping new concepts. We, at the Strathcona Nursery School, are honoured that you are considering sharing your children with us at this exciting and important time in their lives.

The Strathcona Nursery School accepts children aged 2½ to 5 years. Here are some of the highlights of our program:

- Mixed age classes which allow younger siblings to participate in the same class as their older siblings.
- 2½ hour sessions that include outdoor play time, free play, craft, and music time.
- A nurturing, positive and respectful environment that encourages children to explore and be creative.
- Flexibility in session times - choose morning or afternoon sessions based on your schedule.
- A developmentally appropriate program.
- Two creative and dynamic teachers who complement one another

Strathcona Nursery School is a parent cooperative playschool. This means that we rely heavily on parent involvement to keep our school operating. **Parent contribution, through fundraising, board committee or volunteer role participation, and cleaning bee requirements, is mandatory and vital to the operation and health of the school.** Fundraising may include, but is not limited to, working at a casino. There are also regular **duty parent days morning classes only** to ensure a low adult to child ratio. Duty parent days allow you to spend time with your children in a relaxed classroom environment, and to share in their learning experiences.

**Registration is on a first come first served basis. If classes become full, families have the option to be put on a waitlist.**

## **Parent Responsibilities**

As parents of a child registered at Strathcona Nursery School, you are members of a parent-led cooperative playschool, which means that the existence of the playschool depends on your commitment and dedication throughout the school year. The parent body works together toward common goals, the most important of which is to provide a happy, satisfying playschool for our children. Your annual duties in the cooperative are:

### **Duty Parenting For Morning Sessions**

Including a duty parent in the classroom allows a ratio of 5-6 children to one adult. In addition to fostering more direct interaction with the children, duty parents bring new and interesting perspectives to the class every day, and encourage children to share their playschool environment with their caregiver.

Every family enrolled morning sessions at the playschool is required to participate in duty days. When the school is at full attendance this is approximately one day/month. If you fail to attend your assigned duty day, your fine amount will be processed. Failure to attend three assigned duty days will result in the review of your continued membership; at the discretion of the board, you may be asked to withdraw from the school.

### **Fundraising**

**Strathcona Nursery School raises the majority of its budget for teacher salaries by working at a casino once every two years.** Failure to provide the appropriate staff for a casino will result in Strathcona Nursery School losing the opportunity to ever do another casino. As such, participation is mandatory. The other major fundraiser is a Spring Carnival where all families must take on a volunteer role. Both of these events have an associated fine for non-participation (Casino Fine & Volunteer Participation Fine)

Minor fundraising activities (i.e. selling cookie dough, gift wrap, etc.) have been eliminated in favour of a required semi-annual fundraising fee.

### **Cleaning Bee**

Classroom toys are cleaned on a weekly-basis by teachers. Each family is required to participate in a classroom Cleaning Bee once or twice per year. Failure to participate will result in your cleaning bee fine being debited from your account.

### **Board or Committee Participation**

Each Strathcona Nursery School family is required to take on a volunteer position. This may be a position on the Board, on a committee, or a specific volunteer position. There is an associated fine for non-participation in your volunteer role. See Page 5 of the Registration Package for more information.

### **Semi-Annual General Meetings**

All families are expected to attend the semi-annual general meetings held each fall and spring. The spring SAGM will be in early June 2020.

## Student Eligibility

Children must be at least 30 months (2½ yrs) of age to enroll. Children 30 - 36 months of age may only attend the morning sessions. Children are permitted to attend the afternoon sessions after their 3<sup>rd</sup> birthday (subject to availability).

## Class Sessions

A “session” is one morning or afternoon per week. Sessions can be mixed and matched to suit your needs. The following session times are available to choose from when creating your child(ren)’s timetable(s). The number of sessions your child(ren) may attend depends on their age .

## Fee Schedule

Program fees are charged on a monthly basis based on the total number of classes children in your family are enrolled in:

1 session per week	\$ 65/month
2 sessions per week	\$ 130/month
3 sessions per week	\$ 180/month
4 sessions per week	\$ 220/month
each additional session per week	\$45/month for each additional session

*Example: One family has two children in school, each attending three times/week for a total of six sessions per week. Fees are \$310/month (\$220 for 4 sessions + \$90 for 2 additional sessions)*

## Withdrawals

One full calendar month's written notice is required to withdraw your child from the program. If your child is registered in September and you wish to withdraw him/her, you must inform the Registrar by July 31, otherwise September program fees will be charged. **Withdrawals effective after March 31<sup>st</sup> will be charged April, May and June fees.**
