## 4. WHAT ARE HUMAN RIGHTS?

Human rights are fundamental principles that recognize and protect the dignity of all individuals. They include the right to life, liberty, equality, security, decent work, non-discrimination, freedom of expression, health, and education, among others.

## **5. REVIEW AND CONSULTATION**

- Prevention of discrimination, intimidation, and harassment in the workplace
  - All complaints will be investigated confidentially, fairly, and promptly.
    - If verified, proportional disciplinary measures will be applied.
- Gender equality
  - We implement inclusion policies and continuous training on gender equity.
- Child and forced labor
  - Child or forced labor is strictly prohibited in our operations and supply chain.
- Occupational health and safety
  - We comply with current Colombian labor regulations on health and safety.
  - All reported incidents are recorded and investigated for proper follow-up.

#### • Working conditions

• We ensure fair, equitable, and non-discriminatory working conditions.

#### 6. RESPONSE PLAN

- For staff:
  - Violations must be reported to the Human Resources department or directly to management.
  - Complaints must be documented in writing and kept strictly confidential.
  - This policy is linked to the confidentiality and internal whistleblowing policies.
