- Community and Public Relations Marian Wright

- Community Health, Safety, and Welfare Jay Bonham
 - No update at this time regarding the study going on for the placement of a safe, designated school bus stop in the area of 90th street West and Elizabeth Lake Road.

- Community Standards and Land Use Michelle Flanagan
- Ritter Ranch was discussed at the Palmdale City council meeting on April 20 when the City council voted to deny Leona Valley's appeal against the project as it has been proposed.
- History on Ritter The plan was originally approved in 1992, Leona Valley fought against the developer and the development was eventually stopped after much harassment of Leona Valley and its citizens by the Ritter Ranch developer.
- The current plan for Ritter Ranch is lacking and in need of updates. New EIR is needed,
 Updated fire hazard and seismic hazard assessments
- The Current Ritter Ranch Developer has offered a deal to Leona Valley that includes an amended specific plan,
- What Leona Valley and the Town Council have been asking for specifically is a significant buffer zone between the new development area and the existing Leona Valley.
- The LVTC has been working thru an attorney to communicate and negotiate with the City
 of Palmdale and the Ritter Ranch developers. Negotiations are ongoing. The Land Use
 Committee and various Leona Valley residents have spent much time and skills compiling
 lists of changes from the last 30 years.

Public Comments

- Tania Williams
 - Tania Has been in LV for over 40 years. She says the bad people don't live here for long, as there is a special sense of community here. It feels safe and like home. She said a prayer for the valley.
- Vance Kirkpatrick
 - Vance and his family moved to Leona Valley I 1972. Speaking mostly about the traffic concerns, he has to turn up 75th street west in order to get home, and the traffic situation is becoming more dangerous. He feels the City has an obligation to do something to mitigate the heavy traffic on ELR. The Developer getting this first tract in is simply a foot in the door as far as increasing traffic levels.

Linda Koch

Linda says she has been to Palmdale City Council meetings and feels that the city and developer are trying to push thru a bunch of bad ideas and are trying to get things done quickly. She feels that the state water restrictions and will help stop the development if we litigate and push against the developer.

Karl Pearcy

Karl says he feels the increasing price of construction materials and associated items may help Leona Valley's position. He reminisced about lyrics to the songs "big Yellow Taxi" and feels the City of Palmdale needs to support their citizens in promises they have already made and not yet come thru on. Traffic on the 14 freeway is very bad and the Freeway needs improvement.

Peter Weilbach

Peter said he feels the attorney situation can be sticky, "dancing with the devil" He feels that development is inevitable, but we should try to get a covenant recorded on the land in order to restrict development for the future. He feels he has a realistic view of how these developments work and how powerful they are with their deep pockets. He explained how tract approval process works.

Sandy Buchholz

 Sandy is concerned with the increased risks of Valley Fever associated with the mass grading.

Brian Gorrindo

Brian wants to move forward with litigation and push back as long as possible. He thinks that the developer will eventually get what they want, based on his professional experience. He is against public parks in the area as a whole.

Luke Rogers

Luke knows this is a serious fight and encourages community members to participate in all areas of this battle. He calls for the community to come together in this battle. He says the opposition has great strength and a lot of money. We have limited funds and resources for the fight. He is against the project, but believes some part of it is inevitable.

Juanita Kirckpatrick

Juanita was one of the first Town Council members. The first fight was an incredible amount of work and cost a lot of money. She encourages the community to keep fighting and pull together.

Council Member Comments

- Jay Bonham said there are plans for a large number of traffic lights and stop signs between 20th street West and Boquet Canyon Road.
- Judy Anaya Made a motion to pursue litigation against Preston Hollow, The City of Palmdale and Ritter Ranch Developers. Marion Wright seconded.
