## From the President Fred Trusty

Again this year, Bowman Fest (formerly the Aviation Heritage Festival) was a big success. The B-25 bomber and P-51 Mustang were back again, plus there were biplanes, helicopters, a B-17 bomber, and a Grumman TBF Avenger that offered rides. The Avenger was a folding wing torpedo/bomber with a crew of three; pilot, turret gunner, and radio man/bombardier/vertical gunner. This is the same type of aircraft that George H. W. Bush flew and was shot down in the Pacific during WWII. The first 5 planes were produced in May of 1942 and in June all 5 plus the prototype were part of the Battle of Midway Island. Unfortunately, all 6 planes were shot down but none the less, the Avenger proved to be one of the most rugged planes of the war. It not only was the heaviest but also had the most horsepower of any single engine aircraft of WWII.

Last year I think I told you about my ride in a WWII era T-6 trainer. This year I experienced the 1900 HP of the Avenger from the radio man's seat just behind the pilot. Sitting on the parachute and strapped in tight during a 60 degree 2-G turn is beyond expression. At least no one was shooting at us. I can't imagine being 18 or 19 years old knowing that you only had a 50% chance of surviving. The WWII generation was truly, "The Greatest Generation."

I have to admit that I was a little disappointed, though. They wouldn't let me have any ammunition. Maybe next year I'll bring my own torpedo.

Back on the ground, a little bit about the AACA show and swap meet in Hershey. We had beautiful weather all week but for some reason attendance at the swap meet was down. I talked to a lot of vendors and most said the same thing. But back at space GDC 31 sales were booming. My pickup truck bed was full of thousands of dollars' worth of rare and valuable items (junk) to sell and I sold everything except 7 items. I put a sign on the table that says, "Prices are marked on each item. Put the money in the passenger side window." I leave the window down about an inch with a sign that has an arrow pointing up that says, "Put money here." By doing this, I can walk around the swap meet and find more valuable stuff to buy. I've been doing this for at least 5 years and have never had anyone take something without paying for it. If fact, someone keeps putting pennies in the window. That's how I ended up with a total sales figure of \$113.66 which is a record for me.

The show on Saturday morning had just over 1200 vehicles registered. People line the streets just to watch the cars driving onto the show field. One of the rarest and one of a kind vehicles was an unrestored 1928 Packard roadster with a 1930 Curtis 5<sup>th</sup> wheel camper. The fifth wheel was in the trunk. The trunk lid was removed, of course. The best part is the owner drives it regularly.

An update on the new AACA Library and Headquarters building. The building had been gutted and renovations will start in the next few weeks. This building is next to the show field and swap meet so it couldn't be in a better location. The library is experiencing tremendous growth with several large historically significant collections coming in the next several months. Most members don't realize but the AACA Library houses literature for about a dozen other marque car clubs. It is truly the premier automotive library in the world and has provided valuable information to thousands of people. The library staff has devised a method to digitize old literature to make it readily accessible to people electronically. This is an ongoing process and the new building will help speed things up with some space to work. If it was a printed automotive related document, the AACA library probably has it.

This is a 10-million-dollar project and so far we have raised 7 million dollars but we seem to have hit a plateau. All 21 AACA directors have made a contribution to the best of their ability. Most members with the ability to make a big donation (\$100K or more) have done so with generous contributions so now we need help from the average AACA member. If you are over the age of 70-1/2 you are required by the IRS to annually take what is called RMD (required minimum distribution) from your IRA. You have to pay tax on that money if it's in a traditional IRA. Since AACA is a 501(c) 3 you can make a deductible donation directly from your IRA to the building fund which means the tax owed on the RMD is cancelled by the tax deductible donation. If every member made a \$50 donation, the building would be paid for. For more details, call me or AACA at 717-534-1910. This project is a defining moment in the antique automotive hobby.

I wanted to let everyone know that Joyce Purdon has moved to Oregon to be with family. For several years. Joyce was the clubhouse rental chairperson and we wish her all the best in her new home.

We still have several events coming up in the next couple of months so I look forward to seeing everyone. If you know anyone that has a torpedo for sale I'm in the market for one but I only have \$113 to spend. Unless it's a TBF Avenger, keep the rubber on the road and the shining side up.

#### **BOWMAN FEST 2019**

What a unique event with perfect weather this year! The Bowman Field Airport celebrated its 99<sup>th</sup> year with Bowman Fest on Saturday, October 5<sup>th</sup>. It started with a 5K run on the runway race that had approximately 600 participants.

Last year saw KYANA cars placed among some of the airplanes on static display, but this year, due to a larger number of airplanes arriving, and the amount of early foot traffic on Saturday morning (provided by the runners), we were able to display our old jalopies on the runway. What a unique and one in a lifetime occurrence to see about 25 beautiful show cars being escorted down a runway while vintage planes were taking off and landing around them. KYANA showed up with a very diverse group of cars that was very well received by attendees. Our location on the runway was easy and on the autos and easy on the large number of spectators that went by. The show directors estimated about 10,000 people attended on Saturday and a little less on Sunday. Plus, our runway location made it easy to leave the airport at any time.

Lynn Harpring summed things up well by stating, "Bowman Fest was a great event. In addition to the many fine KYANA people with interesting, rare and beautiful autos, the airplane exhibit of antique and unusual planes was a real crowd pleaser as well as the other ancillary attractions. We had a great lunch on both days, with Saturday being pizza from Bearno's and with Sunday being homemade sandwiches from Morris Deli rig down the road. Plus, the organizers placed a 20ft. by 20 ft. tent for us to use during the festival.
