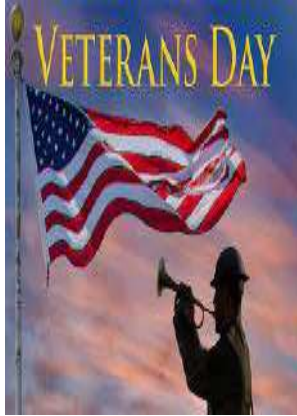

## KYANA CLUBHOUSE CLEAN UP

Just a quick update on the status of several ongoing issues at the KYANA Clubhouse. There is a large tree that partially fell during the most recent storms. It is next to the parking area by the driveway entrance to the clubhouse. There are requests for bids to remove the debris and the remainder of the tree. As a short-term solution Fred brought out his backhoe and he and I cut up the fallen tree section and pushed it over to the corner of the parking lot.

While there was access to the backhoe, I asked Fred to remove all the old overgrown Barberry, Euonymus and Yews that were in the berms around the parking lot. There was a total of 15 bushes that were dug out and added to the debris pile. With these bushes removed, the "parkers" who were using the bushes as a place to hide for romantic activities is no longer an issue.

While this was going on, Carol Bass trimmed the remaining shrubs and cleaned up all the debris.

There is still more that needs to be done to the grounds. We need to rent a dumpster for the disposal of the huge pile of limbs. We need to backfill the berms with top soil where the shrubs were dug out, rebuild the trash enclosure, which is falling, and weed and mulch the bed behind the clubhouse.

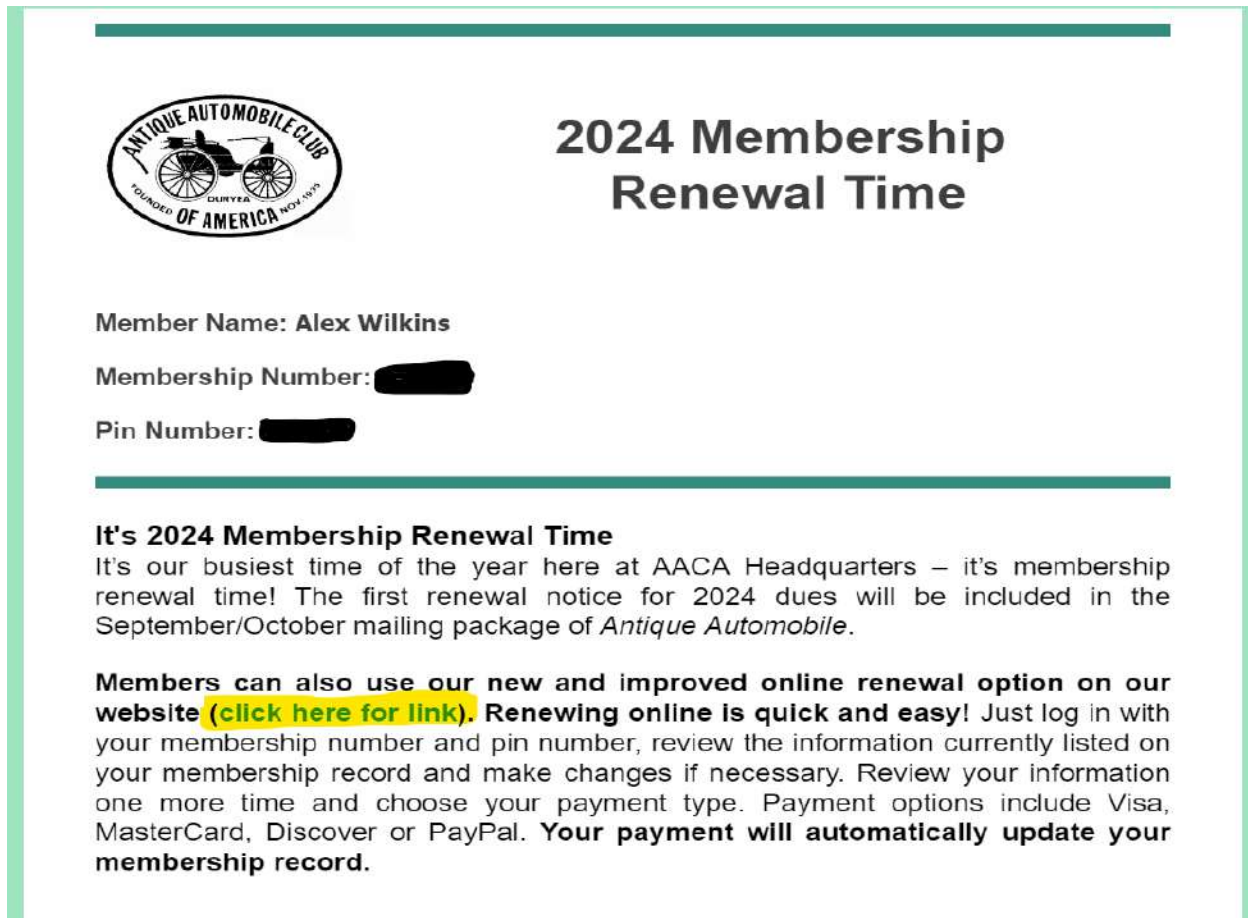
Another more serious issue is the aging HVAC system. The system is almost 25 years old and, at the time of this writing, one of the three condensing units is dead and not worth the cost to repair it. The other two units which are the same age won't be far behind. I have put out a request for bids and the KYANA Charities Board approved to spend up to \$22,000 on new heating and air units. ## !! AACA and KYANA Membership Renewals – NEW FOR 2023!!

It's that time of year again for us to renew our memberships with both AACA and KYANA!

This year we have a new option of partial online renewal since AACA has adopted a new system making national dues easier than ever to pay. If you receive emails from AACA, you may have already seen a notice titled "2024 Membership Renewal" that looks like this:



If you click on the link in the email (highlighted above for emphasis), it will direct you to the AACA website where you can update your membership details and pay with a Credit/Debit Card or with PayPal.

Since AACA has made this option available, you are free to choose it when paying for your AACA National Membership dues. When you turn in your separate membership dues for KYANA, please check the box on the updated KYANA form.

**!! Please be aware that this new option only allows you to pay for AACA dues, NOT KYANA dues. If you fail to pay your KYANA dues separately, you will be removed from the KYANA roster!!**

If you do not receive emails, or if you don't wish to pay online, not to worry – we can still handle your dues the way that we have been doing before. Just submit a single payment of \$55 to cover both AACA and KYANA, and the club will submit all paperwork and money on behalf of those who take this option, just like before.

**!! Regardless of the option that you take, dues must be received (not postmarked) before December 1, 2023. !!**

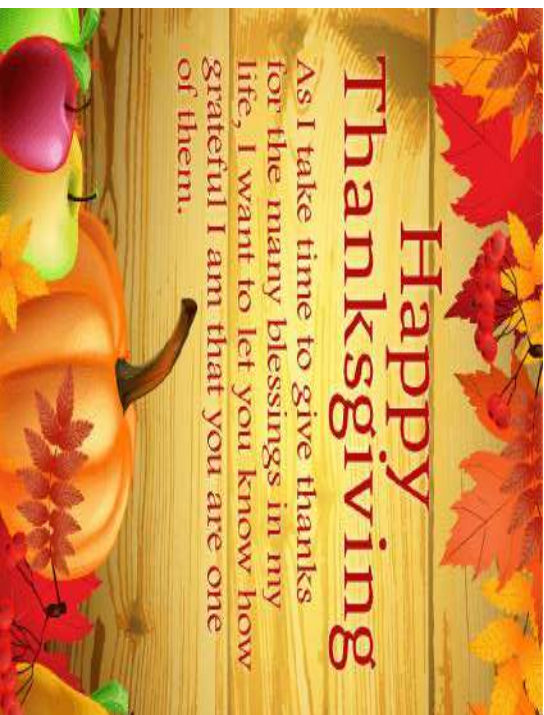
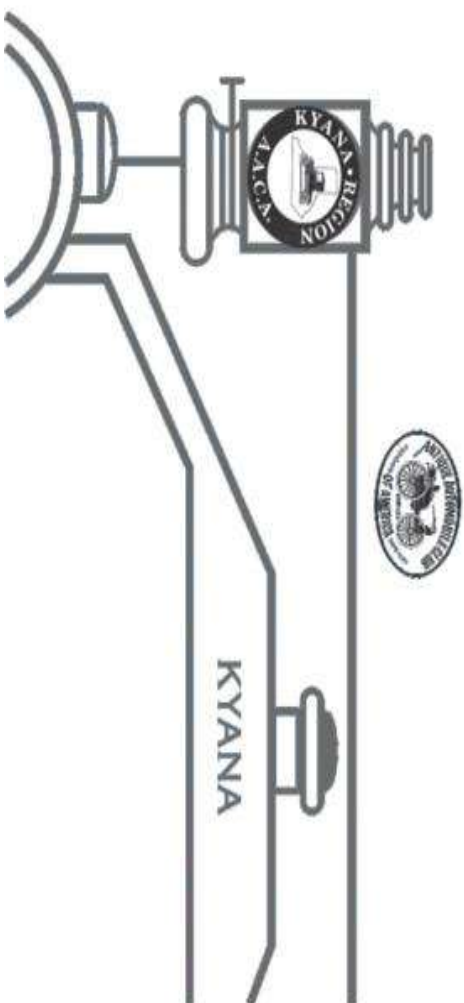
