Renovations and updates are top on the list for the clubhouse. The most important thing regarding the clubhouse is the replacement of the three heat/AC units. As of the date of this writing, both basement furnaces have been removed and replaced with new Bryant units and are operational.









The three condensing units outside by the entrance ramp have been removed and will require a larger concrete pad due to the units increased size. Local code requires 36" of distance from the gas meter and at least 12" of clearance between each of the three units, which means a larger 12' x 4'pad will need to be poured. I will be building the form and pouring the concrete the week of Thanksgiving so the installers can come back and install the new units. The whole job, including installation, should take about 3 days to complete. After the awards and elections meeting, demolition of the upstairs AC unit over the women's bathroom will begin.

A note regarding the storage closet in the downstairs hallway by the kitchen

There will be no more items stored in the basement closet next to the kitchen. The city of Louisville inspectors pointed out that this area is a <u>cold air return ONLY for the HVAC system</u> and there should be no chemicals, cleaners, mops, brooms, or other items stored in it due to the risk of drawing chemical vapors into the air system and potentially making the building occupants sick. I am putting a lock on the door to discourage its use as a storage area.

Locks, Light Switches, and Drapes

Two doors were inadvertently locked and no keys could be found which required members Glen Ray, Marilyn Ray, and Vience Johnson to spend 2 hours picking locks. The two doors in question are the storage room in the basement at the far end of the room and the door to the men's bathroom upstairs. They were able to open the lock in the basement, but not the other. The men's bathroom lock upstairs will require drilling. I will be replacing the two locks with new ones the week of Thanksgiving.

Please do not turn off any light switches that have tape over them and please leave the window blinds open. Leaving a few lights on and the windows uncovered helps LMPD see in the building if they are called to do a security check.

The Trash Can Enclosure and other ongoing work



The trash enclosure was rebuilt by Carol Bass and I a few weeks ago. The old one literally fell over. We were able to salvage the original posts and just replace the panels.

The brush pile in the corner of the parking lot still needs to be removed before winter and a few more bushes will be removed as well. By eliminating the old overgrown bushes, it will make routine maintenance much simpler. This work will be performed by Fred Trusty and me soon.

I will begin working on cleaning up and edging the sidewalks around the property this fall and winter. This is not being done regularly by the mowing company.

THE BIG THREE DETROIT AUTO COMPANIES

How we got here, nowadays, and who knows where cars go in the future?

We have recently been hearing so much in the news about the now settled United Auto Workers Union (UAW) strike against the **<u>Big Three Detroit</u>** auto makers. The media usually refers to them as Detroit's Big Three, The Big Three auto makers, Detroit's Big Three or even simply the Big 3D. What? Is the 3D really the biggest three vehicle makers? Are they based in Detroit? By 2023, there is only partial truth to the **Big 3D**.

The three biggest automobile companies in the world are: #1-Toyota, #2-Volkswagen, and #3-Hyundai-Kia. They are based in Japan, Germany, and Korea, respectively. Next, the fourth largest sized auto company, is Stellantis, the successor owner of Chrysler. Stellantis is a multi-national corporation with large holdings in Italy, France, the U.S.A., and a few other countries; their headquarters is in Hoofddorp - Amsterdam, the Netherlands. They also have a main US office located in **Auburn Hills**, Michigan. Besides Chrysler, Dodge, Jeep, and Ram, they produce a vast percentage of all French and Italian automobiles and some British and German vehicles.

General Motors (GM) is the world's fifth biggest automobile manufacturer, and GM is the only one actually headquartered in **Detroit**. Ford is sixth in the size ranking of vehicle making businesses, and Ford's F-Series truck is for years the best-selling US vehicle; their headquarters is in **Dearborn**, Michigan. Tesla, based in Austin, Texas, comes in as the number 10 in volume car sales-ratings; they are the largest at producer of electric vehicles in this country. Auto sales numbers in the US are

currently led by Ford as the best-selling brand, ahead of #2- Toyota, and General Motors is #3 in domestic vehicle marketing numbers. It seems that two car companies are considered to be among the world's largest financial corporations: Tesla at about 5th place and Toyota at 33rd.

Henry Ford in his third attempt at forming an automobile business, started the Ford Motor Company in 1903, and of course, it took off in 1908 with the Ford Model T. At about that same time, William C. Durant began forming what became General Motors with a conglomerate of automobile brands. Then in 1924, Walter P. Chrysler joined the Maxwell Motor Company and the American Motor Body Company to form the Chrysler Corporation. There are those who also refer to <u>other Big</u> <u>Three</u> auto makers: a big three in Japan at Toyota, Nissan, and Honda; one for France with Renault, Peugeot, and Citroen; and Volkswagen, Mercedes-Benz, and BMW as the German big three version.

Some of this information was somewhat surprising to me, to some of you too? These major companies have offices, manufacturing sites, and assembly plants throughout the world in multiple countries. China, the world's biggest automobile builder since 2008 already has large firms selling car brands like Changan , Chery, Dongfeng, FAW, Geeley, Great Wall, and SAIC; there are about a dozen domestic vehicle varieties being manufactured there. Reportedly, China is said to be the number one country in electric vehicle production and makes well over a third of all the world's car production. There are also "foreign-imported" cars coming to China, that include Audi, BMW, Mercedes-Benz, Porsche, Tesla, Volkswagen, and with Toyota – as the biggest recent one. GM's Buick had been a popular brand made in China, long built there, and a big moneymaker for GM. In 2022, Buick had about 1% of the Chinese automobile market and that accounted for 80% of all Buick sales world-wide. These companies and their rankings vary a lot with changes in market sales.

For most of us, during much of our lives, the Big Three Detroit automobile makers were really the biggest three in car production. The U.S.A. emerged from World War II to be the most powerful nation in many ways, and that was especially so in manufactured goods. Remember, many British, French, German, Italian, and Japanese factories were destroyed and not making family cars, while here, automobile production restarted soon after the war was over. China, India, and Korea were not yet doing much motor vehicle manufacture.

In 1946, after World War II, Volkswagen (VW) was saved as an automobile company by the British military once they occupied what became the British sector of West Germany. With only very few car sales, VW started in the US in 1949, and was originally made fun of. However, as sales escalated, Volkswagen got popular, even a fad option, and a decade later was part of the precipitant for the Detroit Big Three to enter the compact car market. Beginning in the late 1950s, there were multiple reasons for why all our national-brand car sales began to decline. It was a competitive marketing field (... it still is!).

First, there was increasing competition from European and Asian businesses, especially so beginning in the late 1950s. Partly to counter this rivalry and to be more economical, witness the 1960 Corvair, Falcon, and Valiant. Also, Lark, Metropolitan, Opal, Pacer, Rambler, Vauxhall, and a whole bunch of others were into the more fuel-efficient car spirit of that era. The 1960s' public appetite for smaller cars added to the trend and the mid-1970s' national energy crisis furthered that direction. Some people back then were already saying that the US companies were paying too little attention to what their customer base wanted. There were several US car company fiascoes with generally poor-quality cars that damaged reputations. Here are just two examples: the Ford Pinto with its gas tank fires and overheating by Chevrolet Vega engines. Imported cars also were increasingly well-made, boasted better gas-milage, and US companies were perceived as producing less good technology and substandard manufacture. Any time the brand name of an item is widely viewed in a negative way, that reputation has persistence and yields a decline at brand purchase loyalty.

Many established Detroit Big Three US brands disappeared: Continental, Edsel, DeSoto, Imperial, Oldsmobile, Mercury, Plymouth, Pontiac, and the whole American Motors Company lineup. And before that there were other non-Big Three demises including: Allstate, Heny J, Hudson, Kaiser, Frazier, Metropolitan, Nash, Packard, Studebaker, and more. There were also hundreds of firms that had already long disappeared from the late 1800s through the 1940s, like Auburn, Cord, Duesenberg, and way too many more to list here.

As foreign cars got increasingly popular, with firm brand loyalty and prestige factors, that pushed up their market share. Some are still prevalent, such as BMW, Land Rover, Mercedes-Benz, and VW, while others faded from the market, like Fiat, MG, Opal, Peugeot, Renault, Saab, Triumph, and Vauxhall. Still others stayed, but in smaller volume like Jaguar, Ranger Rover, and Volvo, but all that reduced domestic purchase percentages and profitability. There are also a host of less common, expensive other import options, like Bentley, Ferrari, Rolls-Royce, Lamborghini, Maserati, and still lots more. With all these other newer automotive alternatives to choose among, that adds to competition and down-pressure on US or any other company's sales.

Japanese and Korean companies only came late to the US market, and they were initially considered to be suboptimal in design and manufacture; however, that quickly changed dramatically over a short time. As our population gained confidence in these brands, they built a substantial customer base. Japanese cars first came to the United States in the 1950s, but they did not make much market impact until the 1970s; manufacturing here began in the 1980s. These latter years gradually saw the emergence of Korean automobiles. Many of our citizens deplore the fact that US name brands were in relative decline, perhaps more so for older folks than young ones.

Nowadays many of the top-selling, once "foreign" vehicle makers operate manufacturing and/or assembly plants in the U.S.A., as well as in their home countries. Some examples include BMW, Honda, Hyundai-Kia, Mercedes-Benz, Mitsubishi, Nissan, Subaru, Toyota, and Volkswagen. In addition to cars, Volvo is also big into the larger truck manufacture. Several non-3D brands are already very productive at lots of pickup trucks in this country. Since these smaller trucks and larger SUVs are now 50% of the US market, and with so many companies to choose from, that created an additional loss of US market share for our 3D. True or false, many people perceive Japanese and German cars as being the best of the bunch.

Between 1913 - 1925, Ford in Louisville was an early producer of Ford Model T's, and Ford has for a long-time had two truck factories here. Kentucky's Corvette assembly plant began operations in 1981 in Bowling Green. Our Georgetown, KY, Toyota Motors Company factory started in 1986, with its first cars in 1988, and reportedly it might now be the world's largest automobile factory, making over half a million Toyotas annually.

Interestingly, many of these new auto factories are not unionized, while Stellantis, GM, and Ford have UAW contracts. Unionized businesses generally have better pay and benefits - like vacation time, work environment, and retirement plans. The non-unionized ones offer less regulation, cheaper production costs, and greater potential company profitability. The high income of many of their management personnel is a point of contention for many of those companies with and/or without a union. The just ended 2023 UAW strike outcome will profoundly impact the future of automotive manufacturing in this country. It has profound implications for the electric vehicle, battery, and infrastructure production plans since corporations use some of their profits for "becoming electric." News about this topic updates quickly.

The increasing advent of electric vehicles (EV) adds to an unpredictable future. There are numerous issues about rareearth metal procurements, transport shipping, material processing, computer chip or other technologies, and battery manufacture. Beyond battery cost and weight, there are other considerations regarding the duration of battery life. There is much anxiety about the cost of replacing and recycling worn-out batteries and stories about specific batteries not being available years later when needed. Some EV car owners already complain about batteries not being replaceable over time, while the car itself is otherwise still good, and has thus become worthless - even as secondhand options. This issue has become an increasing concern globally. Also, the public needs to know more about the influence of cold weather on EVs; very cold temperatures shorten the power duration of a charge and can slow the speed of re-charging. Additionally, fast-chargers appear to deteriorate battery life quicker than slower ones. The large long-distance trucking industry has indicated plans to go electric, too. The influence of driverless cars, taxis, and/or trucks, brings further uncertainty to our future. In recent months, there has been less optimism in EV market-sales, cost, future timelines of car availabilities, more chargers, and/or batteries, and even in less production of pure "electrics." For example, some automakers have more investment in hybrid versions and maintain parity also with engines using gasoline, diesel, or a host of alternate fuels (e.g., ethanol., propane, natural gas, hydrogen, etc.) and many different types of batteries or fuel cells, or even other power options. Nowadays, with more big SUVs, vans, and pickup trucks, saving energy and/or the air quality seems much less of a market force, despite what our government advocates and the public generally says. Witness the significantly increasing weight of average cars sold in this country. Heavier vehicles add stress to roads, bridges, and requires bigger tires - also requiring more energy expenditures. Producing these cars, especially those with high-capacity automotive batteries, escalates cost to our society, environment, and government. Fewer assembly line workers may be required to assemble an EV; much manufacturing arrives already built and ready to go from the electric motor company. What about workers at electric motor companies? Expensive pricing of vehicles these days has become an escalating problem, and even more ominously so for people in the used, second-hand market.

Beyond the above electric vehicle issues, there are still more matters to confront. Consider the new need for building charging stations with wide, equitable accessibility. What about the cost of installing millions of charging stations, conveniently located for the wider public, time involved for a recharge, who pays for charging, and how is that energy consumption to be taxed? We have only started to establish the hopeful strategy of recycling of components from worn-out batteries.

Kentucky is betting on batteries. The Blue Oval SK, a lithium-battery manufacturing company together with Ford is currently building a huge factory in Glendale, KY. Similarly, Envision AESC has plans for battery-making plant in Bowling Green. However, the future of these facilities is uncertain; one of them is said to already maybe be (?) cancelled. A battery recycling plant is scheduled to be built in Hopkinsville as well. The EV market, results of the strike, and world events will influence the final results.

In addition to the worldwide struggle for procurement of certain materials needed for battery manufacture, even in this country, there is infighting over securing lithium, for example ... everybody wants lithium to be available for their own new batteries, but lithium must just not to be "mined from my backyard." Sources cite Bolivia, Argentina, the U.S.A., Chile, and Australia as the countries with the biggest quantities of lithium; Nevada and Oregon seem to have our largest deposits. China appears to be the main supplier of lithium to this country, mostly for battery production. Similarly, there is also conflict in many locations over the placement of extensive solar-energy capture fields, or for large land-based wind farms or even those off-shore in oceans. We all want the power, but "absolutely do not want that to block our beautiful view." In the meantime, what do we do about our lack of energy independence, a weak electric grid, need for more energy infrastructure, existing natural gas pipelines, and what about all the existing gasoline filling stations, their personnel, supply trucks, and equipment, etc.?

The partisan infighting in our governments at all levels compromises getting something done for the common good. We are experiencing rising oil prices, political indecision about how to deal with that, and with some of it not even in our control, like the big impact from wars in many critical places. Obviously, the automobile business is buffeted by many factors, and they are a huge part of our society and financial balance sheets. So much to think about – not just about cars, but also with them - lots of personal, social, financial, engineering, energy source, national, and world-wide political considerations.


