

Meeting called to order at 6:30 pm

Secretary's Report: Tim Truax moved to accept the October report, Shawn McDonald seconded the motion. The motion carried with all in favor.

Treasurer's Report: Stan Gaus moved to accept the September report, Brian Koressel seconded the motion. The motion carried with all in favor.



Editor's note: Bluegrass World of Wheels started in 2022, five years after the end of the Carl Casper Custom Auto Show, which ran in venues across the country, including here in Louisville, from 1963 to 2017. Carl Casper, a car designer and engineer, built his own cars from scratch, including bodywork, engines, upholstery, and paint. His interests go well beyond cars, and to many, he is the definition of a "renaissance man". He designed and built some of the best known custom cars in the country.

Over the course of 55 years, he produced, co-produced, or collaborated on the production of over 1,000 car shows across the country. One of the biggest was right here in Louisville. 

KYANA REGION AWARDS & ELECTION MEETING

SUNDAY, NOVEMBER 23rd

At the November 23 Awards & Elections meeting, 120 KYANA members approved a bylaw change and elected several new Region board members. Special thanks to George Fackler for volunteering again to run the election process.

With a suitable quorum in attendance, the following proposed bylaw change regarding 50-year-plus KYANA membership was unanimously approved:

The board proposes to add the following language to ARTICLE III – MEMBERSHIP:

Section 7: Any member who achieves 50 years of continuous membership will be designated as a KYANA Lifetime Member. KYANA dues for such lifetime members will be waived in years 51 and thereafter.

In the Region board elections, there was one candidate for each of the four officer positions: Mark Kubancik for President, Chester Robertson for Vice-President, Shawn McDonald for Treasurer, and Carol Bass for Secretary. With no floor nominations, a motion to elect

the four officers as a slate was made and seconded. All officer candidates were summarily elected by acclamation.

Several days prior to the meeting, Bill Willhoite informed the Region board that he would be resigning his Region board member-at-large seat to allow all three qualified candidates for the board to ascend to the board without the need for a contested election. With three board seats now open, the three board candidates, Stan Gaus,

Reagan Lanum, and Ned Steinke, were presented to the members as a slate of candidates. With no floor nominations, a motion and a second was made to elect the three candidates to the board. All three members were summarily elected byacclamation.

The board wishes to thank outgoing board members Tim Truax, Alex Wilkins, and Bill Willhoite for their service and dedication to the club. We also welcome new board members, Carol Bass, Reagan Lanum, and Ned Steinke, to the board and look forward to their contributions and new ideas.

Thanks to everyone who attended the meeting and participated in the club's election process.

WHO WAS RUDOLPH DIESEL (and some Diesel Engine History) by Steve Lippmann



Rudolph Diesel was born in

1858, of German background, and initially lived in France. During the 1870-1871 Franco-Prussian War, his family moved to England, where as a teenager he began an interest in mechanical things. Later, back in France, he started his engineering education and, at age 20, published an article on internal combustion engines. Subsequently, he moved to Germany to pursue further studies in engineering. He had an early focus on ammonia gas-fueled internal combustion engines. At school, he also concentrated on the heat-to-power ratio of steam engines and which stimulated his coming expertise in engine efficiencies. Thus began his concept version of internal combustion that would achieve explosions from high compression-heat induction rather than secondary to a spark. By 1878, his work was directed at advancing engine proficiencies. That yielded designs of compression-ignition that included his first engine patent in 1892. This coal-dust-fueled

internal combustion engine was a forerunner of modern diesels.

Some predecessors to his designs came from the Nicolaus Otto engine, a 4-stroke early internal combustion version. Some other engines utilized glow-ignition and still other ideas, using different cycles, methods, and/or fuels, including ethanol, kerosine, gasoline, etc. Earlier types of air blast injection were copied from previous inventors, and supercharger prototypes were also experimentally added.

Over time, Mr. Diesel shifted to a refined petroleum hydrocarbon liquid fuel of the type that we now call diesel. In partnership with some German companies in 1893, he patented his first real diesel engine. This technology was initially not well appreciated by most automotive and/or engine builders at the time; however, later diesels were gradually improved, gained recognition, and increased in acceptance.

Research focused on temperature and compression adjustments to promote better ignition and combustion without the use of electric sparks, while sparing lost unburnt fuel. Pressures often ranged at 60-to-90 times atmospheric pressure and temperatures from 700-800° centigrade (nearing 1500°

Fahrenheit).

Diesels can operate in two-stroke or four-stroke versions and are highly efficient. Air enters the cylinders during the intake stroke and is next highly compressed to such a degree that it dramatically raises the temperature. Then, once fuel is injected into the combustion chamber, it ignites, creating an explosive power stroke. Torque is controlled by increasing the fuel-to-air ratio.

In the early 1900s, the most common initial adoption of diesel engines was for railroad locomotives, ships or boats, and agricultural machines. They expanded widely to stationary use in heavy equipment and to run electricity generation power plants, where low speed, large size, and heavy weight were not a concern. They then began replacing steam power. Some of the biggest diesels were 14-cylinder, twostroke marine engines. Trucks, especially big versions, commonly are diesel-engined, especially since torque output is stronger than with gasoline engines.

By 1897, Rudolph Diesel's betterfunctioning models were achieved. After exporting his diesel design to many countries, including the U.S.A., he achieved high acclaim, and demand for his engines expanded. By 1898, he reportedly became wealthy.

Nevertheless, years later, he

supposedly became depressed and might have committed suicide. Details are sparse, but some say that he may have jumped off a boat in the English Channel. Perhaps there was some criminal event (like robbery) or that he wanted to hide his presence (and money). Nevertheless, in 1913, it was reported that he could not be found once having boarded the ship, Dresden, for a sea crossing from Belgium to England.

Diesel engines became more popular around the time of World War II. In many, but not nearly all cases, diesel fuel was a possible, more powerful, and safer choice for military vehicles, especially tanks. Due to lower volatility as compared to gasoline, it is less dangerous for troops due to fewer vehicular fires, but also harder to start the engine during cold weather.

Diesel-powered automobiles long existed in small numbers, but mainly were delayed until the world's energy crisis of the 1970s; they were then sought after because of their high fuel efficiency ratings. By 2012, diesel-powered cars had become popular. However, this subsequently dissipated due to concerns about pollution and was further diminished by upset customer reactions to several car manufacturers cheating on emissions reports.


