COVID-19 RELEASE & HOLD-HARMLESS AGREEMENT

PLEASE INITIAL BELOW:

_____ I assure that the participant/player does not have any of the following symptoms:

SHORTNESS OF BREATH
DIARRHEA
MUSCLE PAIN
FEVER OVER 100.0F

COUGH
CHILLS
HEADACHE
RASH

SORE THROAT
DIFFICULTY BREATHING
MUSCLE WEAKNESS
LOSS OF TASTE OR SMELL

_____ I assure if the participant/player exhibits any of the above symptoms, they will stay home until symptoms have subsided, at the minimum of 14 days

_____ I assure that the participant/player has had no known contact with a person who is lab confirmed to have COVID-19 in the past 21 days

_____ I assure that if the participant/player comes in contact with a person who is lab-confirmed to have COVID-19, or they, themselves, test positive for COVID-19, I will notify the Dugout Baseball Academy and coaches, and keep the participant/player out of the facility and off the practice field, in quarantine, for a minimum period of 14 days.

_____ I understand that the Dugout Baseball Academy, and Los Tigres Baseball coaching staff have the right to request a participant/player to leave the facility and/or practice if they suspect the participant/player to be ill, or exhibit symptoms that could be related to COVID-19

_____ I understand that it is my responsibility to ensure my participant/player is in good health, and symptom-free at least 24 hours prior to, and up to the start of the scheduled lesson/practice time, and will notify the Dugout Baseball Academy, and Los Tigres Baseball coaching staff should the participant/player begin to exhibit experience symptoms within that timeline.

_____ I have read and agree to abide by all COVID-19 policies and protocols put forth by the Dugout Baseball Academy, and Los Tigres Baseball, and all coaching staff.

The undersigned understands that exposure to disease-causing organisms and objects, such as COVID-19, and personal contact with others, including but not limited to employees, coaches, players, parents, siblings, participants, owners, occupants and others associated with baseball training, baseball lessons, and base all instruction, involves a certain degree of risk that could result in illness, permanent disability, or death. The undersigned also acknowledges that it is impossible to screen and/or monitor all such individuals. After fully and carefully considering all the potential risks involved, I hereby assume the same and agree to release and hold-harmless the Dugout Baseball Academy, Los Tigres Baseball, and its employees, officers, agents, contractors and coaches from and against all claims and liability resulting from exposure to disease-causing organisms and objects, such as COVID-19, associated with me and/or my participant/player either viewing or participating in baseball training / lessons / instruction / activities.
