Inhalation: May cause drowsiness or dizziness. May cause respiratory irritation. Peripheral neurotoxicity has been reported in connection with over exposure to n-hexane. Prolonged exposure over a period of weeks or months to levels well above the TLV may cause neurotoxic disease, with symptoms including weakness and lack of sensation in fingers, hands, arms, feet and legs. Extinguishing Media
