For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday, respectively, and must be submitted at the trial.

After Closing” Waiting List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on June 11. The waiting list will be active until its deadline — Monday, June 23, 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.
