All entries must be submitted on official AKC Agility entry forms, one dog per entry form.

Photocopies of entry forms without the AKC Agreement are not acceptable.

Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address, or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed.

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registrable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

AKC Jump Height Cards

All dogs competing in agility must possess an official AKC Jump Height Card. **You are not required to show your height card or send a copy with your entry. You are required to mark on your entry form if your dog needs to be measured.** For more information, please visit http://www.akc.org/events/agility/jump_height_card.cfm

Move-ups / Lateral Moves

A move-up is defined as moving from one class to the next higher class. A lateral move is moving an entry from a Regular class to the equivalent Preferred class and vice versa.

For the Friday trial: Move-ups and Lateral Moves close at 6:00 pm CT, Nov 16th.

Moves may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, email confirmation of the move will be sent.

For the Saturday and Sunday trials: MOVE-UPS and LATERAL MOVES close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial.

Mailed/emailed moves close at 6:00 pm CT, Monday, November 16th.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary with the AKC Agility Measurement Form when requesting the class change.

"After Closing" Waiting List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on Nov 4th. The waiting list will be active until its deadline – November 16th, 2026, at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run cannot be replaced, the exhibitor will not receive a refund, and the dog will be considered absent for the run. Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

Gateway Agility Club of Suburban St Louis may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim for refund by letter hand- delivered, emailed, or postmarked before the trial commences.

The club will refund all but \$10.00 of the entry fee per day for injured dogs or handlers. A written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's or doctor's letter must be provided within one week of the trial.

THE CLUB WILL ALSO REFUND ALL BUT \$10.00 OF THE ENTRY FEE PER DAY FOR THAT DAY AND THE FOLLOWING TRIAL DAYS FOR HANDLERS WHO THINK THEY MAY HAVE COVID-19. YOU MUST CONTACT THE TRIAL SECRETARY BY EMAIL AT LEAST 30 MINUTES BEFORE THE START OF YOUR FIRST CLASS OF THE DAY. NO DOCTORS EXCUSE NEEDED. IF YOU ARE SICK, STAY HOME!!!!

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such a case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Gateway Agility Club of Suburban St Louis has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Gateway Agility Club of Suburban St Louis does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

No refunds will be issued for overpayment of less than \$12.

Checks for canceled or incomplete entries will be shredded. No check will be returned.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested with Gateway Agility Club of Suburban St. Louis, or in persons to whom assignments of such rights have been made in writing by the Club. Photographs and/or video recordings taken for any reason other than personal use are strictly prohibited.

Trial Information

Setup time on Thursday will be announced after closing.
Trial hours are 7:00 am to 30 minutes after completion.
Course Maps will be posted on the Trial Secretary website each morning, and will be posted at the trial site. PAPER COPIES WILL NOT BE AVAILABLE.
Ring size: 85' x 105' (2 rings).
Electronic timing will be used at these trials.
The building is climate controlled. There is plenty of close parking and crate space.
Please bring chairs and crates.
Ground cover (mats, tarps, etc) must be placed under crates.
NO SMOKING or VAPING is allowed in the building.
Dogs may not be left in the building overnight.
No outside food or beverages (including alcohol) may be brought into the Event Center.

Prizes and Awards

Rosettes will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes.

1st place.....	Blue
2nd place.....	Red
3rd place.....	Yellow
4th place.....	White
Qualifying.....	Green

An AGCH rosette will be awarded to any dog finishing an AGCH title at these trials.
A MACH rosette and bar will be awarded to any dog finishing a MACH title at these trials.
A PACH rosette and bar will be awarded to any dog finishing a PACH title at these trials.
A PAX rosette will be awarded to any dog finishing a PAX title at these trials.
A new title ribbon will be awarded to any dog finishing a title at these trials.
Dogs qualifying in both Master Standard and Master JWW at the same trial will receive a "Double-Q" award (value less than \$1).

Vendors

Vending at Purina during a GAC trial is through pre-registration with the Vendor Chair, Jamie Heberlein, jkitsis@gmail.com. Vendor spaces are 10x10 and cost \$25/day. If you need a larger area, 10x20 space is available for \$50/day. If you'd prefer to donate your products or services to the club's worker raffle, instead of US currency, please let the Vendor Chair know. The products/services should be the equivalent of your vendor fee (\$25/day/10x10 space). **Please note, Vendors may only sell dog treats/products made by Purina.**

Fix and Go On (FNG)

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

Entering For Exhibition Only (FEO)

- For Exhibition Only may be offered at the option of the host club. FEO will allow Exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the Entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height the team is committed to FEO for that run and must declare FEO on the start **line**. **Day of show jump height changes are not allowed.**
- Dogs may be entered at any level (Novice, Open, Excellent or Masters) in FAST, JWW, Standard or Premier classes. If the dog is not eligible for the level entered the team is Committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The Exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.
- Course time for FEO in T2B, JWW, Standard, Premier, and ISC will be 45 seconds.
FAST course times for each class/height are as noted in the regulations.

Exhibitors must exit the ring when the horn sounds.

FEO will be offered in all classes at this trial.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial

Weekend

Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

NOTE: Water is turned off at the individual RV sites in the full service lot from approximately **November 1 to April 14**, thus the nightly rate will be \$35.

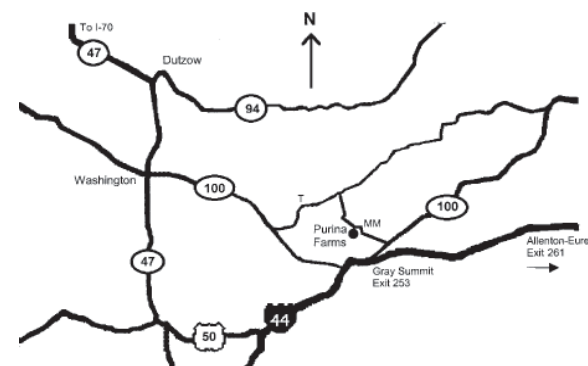
People may fill their RV water tanks at Purina's service center when they arrive.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
