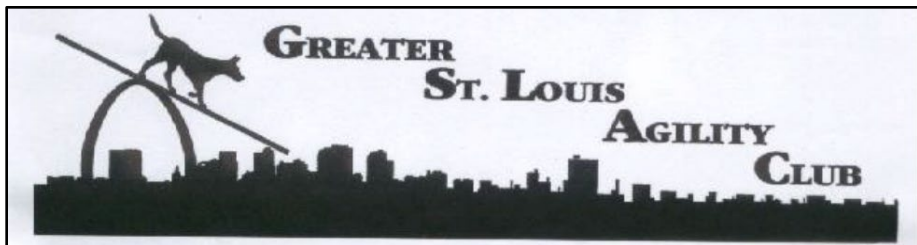

No hand-delivered entries can be accepted in the first 24 hours.

Limit of 10 dogs per envelope.

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address, or enclose a self-addressed stamped envelope.

### Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

### AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. **You are not required to show your height card or send a copy with your entry. ### Move-ups

**For the Friday trial: MOVE-UPS close at 6:00 pm CT, Aug 11.** Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

**For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial.**

**Mailed/emailed move-ups close at 6:00 pm CT, Monday, Aug 11.**

### Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

### "After Closing" Waiting List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on July 30. The waiting list will be active until its deadline- Monday, Aug 11, 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a run cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run.** Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full. *\*Please check the Secretary website for wait list and run availability.*

### Notice to Exhibitors

- The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Greater St Louis Agility Club may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim for refund by letter, hand- delivered, emailed, or postmarked before the trial commences.
- The club will refund all but \$10.00 of the entry fee per day for injured or ill dogs. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- The club will refund all but \$10.00 of the entry fee per day in the form of a club voucher for exhibitors who are absent due to a death in the immediate family.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund of any fees paid will be made.
- All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Greater St Louis Agility Club has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC No." checked.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Greater St Louis Agility Club does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.
- No refunds will be issued for overpayment of less than \$12. Checks for canceled entries will be shredded.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

### **Trial Information**

Set up time on Thursday will be announced after closing.  
Trial hours are 7:00 am to 30 minutes after completion.  
Ring size: 85' x 140' (2 rings).  
Electronic timing will be used at these trials.  
The building is climate-controlled. There is plenty of close parking and crate space.  
Please bring chairs and crates.  
NO SMOKING or VAPING is allowed in the building.  
Dogs may not be left in the building overnight.

### **Prizes and Awards – Regular Classes Revised 5/29/25**

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

1st place.....Blue  
2nd place..... Red  
3rd place.....Yellow  
4th place.....White  
Qualifying..... Green

An AGCH rosette will be awarded to any dog finishing an AGCH title at these trials.  
A MACH rosette and bar will be awarded to any dog finishing a MACH title at these trials.  
A PACH rosette and bar will be awarded to any dog finishing a PACH title at these trials.  
A new title ribbon will be awarded to any dog finishing a title at these trials.  
Dogs qualifying in both Master Standard and Master JWW at the same trial will receive a "Double-Q" award (value less than \$1).

### **Prizes and Awards – ISC Classes Revised 5/29/25**

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

1st place..... Rose  
2nd place..... Brown  
3rd place..... Light Green  
4th place .....Gray  
Qualifying.....Green with Pink edge  
Gold, Silver, & Bronze medals given for 1<sup>st</sup> thru 3<sup>rd</sup> COMBINED (STD & JWW) overall scores.

### **Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend**

#### **Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

### **Fix and Go On (FNG)**

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

### **For Exhibition Only (FEO) – IS being offered in all classes at this trial**

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler may declare the day of the show
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. **Day of show jump height changes are not allowed.**
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge
- Course time for FEO in Time 2 Beat, JWW, Standard, Premier & ISC will be 45 seconds. FAST courses times for each class/height are as noted in the Regulations. **Exhibitors must exit the ring when the horn sounds.** FEO runs will be scored as 'absent' in catalog and results.

### International Sweepstake Class (ISC)

ISC course design is by Esa Muotka

The International Sweepstake Class (ISC) is a non-regular class providing a dog and handler an opportunity to demonstrate their advanced training and handling skills on various international style Standard and Jumpers With Weaves courses. The rules for this class are generally based on Fédération Cynologique internationale (FCI) rules. ISC Course design should reflect current FCI design.

Currently, AKC does not limit entries into International (ISC) classes based on levels. Dogs can run all levels concurrently during the trial, and on the same day. A1 and J1 are the entry levels. A2 and J2 are the Intermediate level. A3 and J3 are the Advanced levels. Dogs can be entered in any or all of the ISC classes during this trial without concern with current AKC levels.

All AKC heights will be offered, except for 24C. dogs may be entered in their regular AKC jump heights or may choose to run in their FCI height category. Dogs may be entered in their Preferred height category and will be scored with dogs running in the corresponding Regular height.

#### ISC Height Chart

Small	Dogs measuring 13 3/4" and less	12"
Medium	Dogs measuring 16 7/8" and less	16"
Intermediate	Dogs measuring 18 7/8" and less	20"
Large	Dogs measuring greater than 18 7/8"	24"

If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners<sup>SM</sup>** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
