### Dogs Eligible to Enter

This trial is open to all Labrador Retrievers fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP).

Dogs with a PAL/ILP number must be spayed or neutered in order to compete.

Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registrable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

## Move-Ups

**For the Monday trial MOVE-UPS close at 6:00 pm CT, Monday, September 29, 2025.**

Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, email confirmation of the move-up will be sent.

**For the Tuesday trial MOVE-UPS close 30 minutes after the end of the trial on Monday and must be submitted at the trial.**

**Mailed/emailed move-ups close at 6:00pm CT, Monday, September 29<sup>th</sup>.**

**\*\*PLEASE NOTE: If you trial after Sept 29 and earn a title, you WILL NOT be able to move up for the Monday 10/6 trial.**

## Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

## Notice to Exhibitors

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

LRC, Inc. May cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim for refund by letter hand- delivered, emailed, or postmarked no later than one half hour before the trial commences. A veterinarian's note must be included with the refund request.

Refunds will NOT be issued for injury or illness after entries close.

Entry Changes: Entry changes made via email will receive an acknowledgement from the Trial Secretary. If you do not receive an acknowledgement, assume your request has not been received. No refunds or changes will be made without the Trial Secretary's acknowledgement.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such a case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. LCR, Inc. has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Please include AKC titles only on entries.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

**Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.**

Exhibitors should follow their veterinarians' recommendation to ensure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

LRC, Inc. its Board Members, and Nestle' Purina Farms and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

LRC Inc. does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Returned checks do not constitute a valid entry fee. **There is a \$35 returned check fee.**

No refunds will be issued for overpayment of less than \$10.

Checks for canceled or incomplete entries will be shredded. No check will be returned.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement

### **The Nina Mann**

The Nina Mann - A Dog For all Reasons Award recognizes those dog and handler teams that compete in multiple venues at the Labrador Retriever Club National Specialty. Eligibility for this award requires entry in three categories- Conformation (Mandatory) AND 1 event in at least 2 of the following Companion/Performance categories: Obedience/Rally, Agility, Scent Work, Tracking Test, or Hunting Retriever Test/Field Trial. Dogs that place in Conformation OR earn a qualifying score in one of the Companion/Performance events will be presented with the Nina Mann Award stone trivet.

### **High In Trial Regular and High In Trial Preferred**

The High In Trial awards will be determined by highest combined score in the standard and jumpers classes with ties broken by fastest time defined in yards per second as calculated by dividing course length (in yards as determined by judge) by the dog's time (in seconds). If a tie should exist, the award will go to the dog from the highest-level class. HIT Regular and HIT Preferred will receive a 16" Silver Tray

### **Agility Top 20 Tribute**

The Top 20 Tribute is to recognize those dogs who best demonstrate the Labrador Retriever. These events are not an award program, but an exhibition held annually during the LRC National Specialty Event Week, to showcase excellence in Labrador Retrievers, in obedience, rally, agility and conformation. These events provide an opportunity to educate exhibitors, judges, breeders and fanciers and a chance to view the top Labradors in competitive standing from the previous year and provide special recognition to their owners and breeders. Participants will receive a commemorative rosette.

### **Fix and Go On (FNG)**

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

### **Entering For Exhibition Only (FEO)**

For Exhibition Only may be offered at the option of the host club. FEO will allow Exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the Entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height the team is committed to FEO for that run and must declare FEO on the start line.

#### **Day of show jump height changes are not allowed.**

- Dogs may be entered at any level (Novice, Open, Excellent or Masters) in FAST, JWW, Standard or Premier classes. If the dog is not eligible for the level entered the team is Committed to FEO for that run and must declare FEO on the start line. Day of show level changes are not allowed.
- The Exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge.
- Course time for FEO in T2B, JWW, Standard, Premier, and ISC will be 45 seconds.

FAST course times for each class/height are as noted in the regulations.

#### **Exhibitors must exit the ring when the horn sounds.**

**FEO will be offered in all classes at this trial.**

### **Entering a Mixture of Regular and Preferred Classes Within the Same Trial**

#### **Weekend**

#### **Multiple Jump Heights Within the Same Trial Day**

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

**All exhibitors must immediately clean up after their dogs on the trial site, including the RV area, and at motels. Any damage to motels, RV sites, or the trial site can result in disciplinary action by the Event committee and result in ejection from the current and future trials. These are AKC supported measures.**

2) The electric-only Main Show Field RV lot offers 30- and 50-amp electricity and has a nightly charge of \$25.

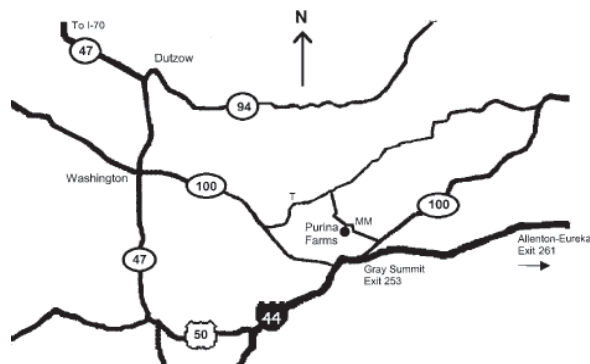

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the **AKC Canine Partners** program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
