- *EXHIBITORS should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- *ALL ENTRIES must be submitted on official AKC entry forms, one dog per entry form.
- *CHANGES, ADDITIONS OR CORRECTIONS to entries must be received in writing or by email prior to close of entries.
- *CHECKS for withdrawn entries will be shredded. No check will be returned.
- *CONDITIONAL ENTRIES. No entry shall be made, and no entry accepted which specifies any condition as to its acceptance.
- *NO ENTRY FEE WILL BE REFUNDED in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.
- *NO ENTRY FEE WILL BE REFUNDED if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause which is beyond the control of the Club or the Trial Secretary.
- *RETURNED CHECKS do not constitute valid entry fees. There is a \$25 return check fee.
- *OVERPAYMENTS of less than \$10 will not be refunded.
- *Since <u>bitches in season</u> are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason, provided that the trial secretary is notified prior to the start of the trial and written verification is provided by a veterinarian.
- *DOGS MUST BE READY FOR JUDGING WHEN CALLED TO THE RING. Neither the club nor any ring steward will be obliged to call or notify exhibitors of when they are due in the ring for judging. Judges are not required to wait for any dog.
- *NCOTC reserves the right to substitute prizes of equal or greater value.
- *NCOTC DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.
- *IF AN EMAIL ADDRESS IS PROVIDED by the owner or agent on the entry form, a notification of the entry receipt will be sent.

Jump Height Order

Jump height order will be Tall to Small for those classes with jumps. Every effort will be made to accommodate handlers with multiple dogs in the same class.

Please include dog's jump height on entry form if applicable.

Pre-Order Catalogs

Catalogs may be pre-ordered at \$5.00 per catalog. Please include payment with your entry fees. Catalogs will not be available for sale at the trial. If you would like a catalog, you must pre-order.

Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or are approved Foundation stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the AKC Rules Applying to Registration and discipline for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.
