- If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped envelope.
- Entries cannot be changed once the trial has closed.

After Closing" Waiting List

A waiting list (30 run maximum) will be maintained for this trial once it has closed on April 24th. The waiting list will be active until its deadline — Wednesday, May 5, at 6:00 pm CT. Any runs that are entered in this trial at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a run cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the trial.** Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Dogs Eligible to Enter

This trial is open to all Dachshunds fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration or Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP). Dogs with a PAL/ILP number must be spayed or neutered in order to compete.

Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Judge's Briefing / Walkthrough for first class.....7:30 am

MOVE UPS (PLEASE READ CAREFULLY)

Move ups for the first course the dog is to run must be submitted to the secretary by 6:00 pm on May 5th. Because we are running two trials in one day, move ups from trial 1 to trial 2 **WILL BE ALLOWED where possible**, BUT move ups from the first run to any subsequent runs must be turned into the secretary immediately upon the judge certifying the qualifying first run and not less than 15 minutes before the second course starts. (For example, if a dog completes their OPEN Standard title during the first trial they may move to the EXCELLENT Standard course for the second trial as long as the move up form is submitted to the secretary at least 15 minutes before the EXCELLENT Standard course begins for the second trial.)

Height Divisions

Owners are responsible for entering their dogs in the proper height divisions as follows:

AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. **You are not required to show your height card or send a copy with your entry. You are required to mark on your entry form if your dog needs to be measured.** For more information, please visit http://www.akc.org/events/agility/jump_height_card.cfm

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary with the AKC Agility Measurement Form when requesting the class change.

Trial Information

The Event Center is available at 6:00 am on Monday, May 12 for setup.

Trial hours are 7:00 am to 30 minutes after completion.

Ring size: 90' x 105'.

Electronic timing will be used at these trials.

The building is climate-controlled. There is plenty of close parking and crate space.

Please bring chairs, crates and water for your dogs, and clean up supplies.

No strollers or playpens will be allowed in the building.

NO SMOKING or VAPING is allowed in the building.

Dogs may not be left in the building overnight.

No outside food or beverages (including alcohol) may be brought into the Event Center.

No spectators or dogs are allowed on the second floor of the Purina Event Center.

No firearms are allowed on Purina property.

Notice to Exhibitors

The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.

The Dachshund Club of America, Inc may cancel this event in extreme weather conditions.

Entry fees will not be refunded if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$10.00 of the entry fee for bitches unable to compete for that reason. The Trial Secretary must receive written notification of such a claim for refund by letter hand-delivered, emailed, or postmarked before the trial commences.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committees, be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The Dachshund Club of America, Inc has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. Include only AKC titles on entries.

Owners are responsible for errors in making out entry forms, regardless of whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot be corrected after the closing date. No refunds for duplicate entries.

Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.

Returned checks do not constitute a valid entry fee. There is a \$20 returned check fee.

No refunds will be issued for overpayment of less than \$5.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.

The Dachshund Club of America, Inc, its Board and Members, and Nestlé Purina Farms and its employees will not be liable for any loss or injury which may be sustained through disappearance, loss, theft, communicable disease, parasites, injury and/or death of dogs entered in this event.

The Dachshund Club of America, Inc does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Purina Event Center is open from 6:00 am to 10:00 pm.

All buildings are NON-SMOKING. Smoking is permitted outside in designated areas.

Dogs cannot be left in the Purina Event Center or the outdoor grooming tent overnight.

All crates must be marked with a contact name and phone number.

No one is permitted anywhere that is marked "Employees Only" and/or "No Admittance." these are separate divisions of Purina and not part of the show grounds.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial

Weekend - Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

For Exhibition Only (FEO)

FEO will not be offered at this trial.

TRIATHLON AWARD PROGRAM**

In an effort to promote the entire Dachshund and showcase the versatility of our breed, DCA awards Triathlon awards Dachshunds which distinguish themselves in performance and/or companion events at the National Specialty through the Triathlon Program.

The Triathlon is a once a year event which happens only at our National. If you enter and participate in at least three of the seven different performance and/or companion event categories (agility, earthdog, field trial, obedience, rally, scent work, and tracking) you can be in the Triathlon competition. Qualifying in an event earns points based on the particular level of the competition. The point schedule is posted on the DCA website. The dog that accumulates the most points including the Conformation evaluation, is awarded "DCA Triathlon Dog of the Year".

All Participants (even if they don't qualify in the 3 events they have attempted) earn a nice commemorative medallion and are recognized by DCA with a Certificate of Achievement.

Rosettes will be awarded First Place through Fourth Place in each jump height in each class. Qualifying rosettes will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes. Qualifying scores are required for awards.

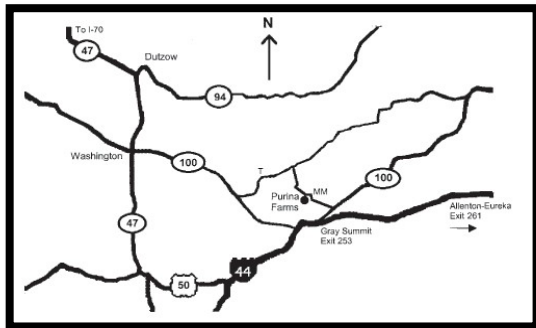

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitor's entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

HONOR RUN OF AGILITY VETERANS

This non-competitive agility run is intended to honor our retired competitors. This run is open to any dachshund that is currently retired from agility and not entered in these trials. The run is planned to occur between the Standard and Jumpers Courses. A Jumpers course will be used and bars will be removed so jumping is not required. A dog can complete all or just some of the course, or just pass through one set of jump standards. A wagon will be provided so dogs that are no longer able to run can also be recognized. At the conclusion of the run, dogs will be awarded a Rosette printed with their titles to commemorate their career.

Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners ProgramSM may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.
