### **SET-UP**

There is no Thursday exhibitor set-up. Set-up available each day at 7:00 am.

### **CRATING**

THERE WILL BE NO PREASSIGNED CRATING.

Crating spaces (3 1/2' x 5' each) will be marked but will not be preassigned. If you save spaces for friends, please place a piece of paper with their name and dog's name on the spot you are saving. For safety reasons, please do not drop mats or tarps to save spaces. We will have paper/pens/tape to help you save spots. If an exhibitor is only entered on Sunday, please do not save them a spot!

Please remember, unentered dogs are welcome but your chair and crate(s) must fit within your crating space.

### **COURSE MAPS**

Exhibitor Course Maps will be available the morning of the trial at <https://gameonk9events.com/agility> on the Triune page. Course maps will also be posted at the trial site. Paper copies will NOT be provided.

### **Move-Ups**

**For the Friday trial: MOVE-UPS close at 6:00 pm CT, Monday, April 28<sup>th</sup>.** Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent. **For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial. Mailed/emailed move-ups close at 6:00 pm CT, Monday, April 28<sup>th</sup>.**

### **FOOD**

Food will not be available at the trial site. There are many restaurants nearby and many deliver. Food may be brought into the building, and you may eat at your crate space.

### **VMO**

Cheri Tyre-Roberts (judge) is **not** a VMO. However, if your dog is under 2 yrs old and has never been measured, or if your dog is over 2 yrs. old and you do not have at least 1 official measurement, you will need to have your dog measured BEFORE your first run.

If your dog needs to be measured, please arrive early to allow plenty of time to get this taken care of.

### **VENDORS**

Jane Rich, Hands-On Canine Massage, LLC will be vending at this trial.

## PARKING

Parking is not allowed in back of the building. The area in back of the building is for ACTIVE loading and unloading ONLY.

Active loading and unloading area will be available close to the front doors as well.

Also - on Friday, parking is not allowed in front of the business on the left as you face the building – the WEST end of the building. (see map below)
