Dogs Eligible to Enter

This trial is open to all dogs fifteen 15 months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes

"After Closing" Waiting List

All dogs competing in agility must possess an official AKC Jump Height Card. You are not required to show your height card or send a copy with your entry. Move-Ups

For the Friday trial: MOVE-UPS close at 6:00 pm CT, Monday, April 28, 2025. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent. For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial. Mailed/emailed move-ups close at 6:00 pm CT, Monday, April 28, 2025.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

Trial Information

- Trial hours are 7:00 am to 30 minutes after trial completion.
- The building is climate-controlled.
- Dogs may not be left in the building overnight.
- Electronic timing will be used at these trials.
- Setup time will be announced after closing.

Crate & Chair Information

Please bring crates for your dogs and a chair for yourself.

Ground Covers (i.e., tarps, crate mats, towels) are required under all crates. For the safety of everyone, all covers must be completely under your crates.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

Fix and Go On is not pre-entered; rather, it occurs during the run. Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on the course when the dog's obstacle performance is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score.

For Exhibition Only (FEO) – IS being offered in all classes at this trial

- For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO is allowed in all classes. Participation in FEO is non-qualifying.
- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the Trial Catalog as part of the results for that class. FEO does not need to be noted on the entry form; the handler may declare the day of the show
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out to the scribe and the judge
- Course time for FEO in Time 2 Beat, JWW, Standard, Premier & ISC will be 45 seconds. FAST courses times for each class/height are as noted in the Regulations. Exhibitors must exit the ring when the horn sounds. FEO runs are scored as 'absent' in catalog and results.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes.

An AGCH Rosette will be awarded to any dog finishing an AGCH at these trials. A MACH bar and rosette will be awarded to any dog finishing a MACH title at these trials. A PACH bar and rosette will be awarded to any dog finishing a PACH title at these trials. A new title rosette will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" award (value \$3.00-\$3.85). Dogs qualifying in Master Standard, Master JWW and Master FAST in the same trial will receive a "Triple-Q" award (value \$7.00).

Notice to Exhibitors

- Dog safety is our primary concern. By entering these trials, exhibitors acknowledge that they are
 familiar with the rules and regulations of this sport and that their dogs are familiar with and able to
 perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by Event Committee action.
- Triune Agility Club of SW Illinois may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials can't be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of public enemy, or any other cause beyond the organizing committee's control.
- Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$15 of the entry fee per day for bitches unable to compete for that reason. Written requests for a refund must be made to the Trial Secretary no less than 30 minutes prior to each day's event start time.
- The club will refund all but \$15 of the entry fee per day for injured dogs. Written requests for a refund
 must be made to the Trial Secretary no less than 30 minutes prior to each day's event start time. A
 veterinarian's letter must be provided.
- The club will refund all but \$15 of the entry fee per day for an injured handler in the form of a voucher. Written requests for a refund must be made to the Trial Secretary no less than 30 minutes prior to each day's event start time. A doctor's note must be received within one week for a refund voucher to be issued.
- People who are experiencing COVID-related symptoms, are self-quarantining, or are involved in COVID exposure contact tracing will be given a refund of less \$15 per day in the form of a future trial voucher. To receive a refund, you must contact the Trial Secretary at least 30 minutes before the trial begins. No doctor's note is required. Any runs for the remainder of the weekend will also be pulled. Please, stay home and keep everyone safe. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.
- It is expressly understood that the exhibitors alone are responsible for their dog's and/or children's behavior. Any exhibitor whose dogs and/or children cause unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund will be made.
- All dogs must be on leash or crated at all times except when in the ring or when in the designated
 agility warm-up area. Exhibitors are responsible for being at the ring gate when it is their turn to run.
 The judge need not wait for any dog holding up a class. Triune Agility Club of SW Illinois has no
 obligation or responsibility for providing service through a public address system or steward for the
 purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete the back of form.
- All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they
 may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog".
 The dog's listing number must be entered on the entry form and "AKC" No. checked.
- Owners are responsible for errors in making out entry forms. No entry will be refunded in the event
 of such errors or entries' cancellation after the published closing date. No refunds for duplicate entries.
- Dogs under 4 months of age are not permitted on the AKC Agility Trials show grounds.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Triune Agility Club of Southwest Illinois does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.
- No refunds will be issued for overpayment of less than \$10.
- Checks for canceled or unacceptable entries will be shredded. No check will be returned.
- Flexi-Leads and X-pens are not allowed in the building.
- Exhibitors are responsible for cleaning up after their dogs. Any exhibitor failing to do so may be excused without a refund if the Event Committee deems the exhibitor violates this requirement.

INSTRUCTIONS

Handlers whose dogs measure into the 8" through 20" regular jump height divisions may opt to enter in a higher or 24-choice height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs who measure into the 24" regular jump height division may not enter 24-choice. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division.

All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine Partners ProgramSM may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767.
