Any damages to motels by exhibitors can result in disciplinary action by an Event Committee hearing so please take care and make sure to respect their property.

#### **Transfers**

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial. Transfers may be submitted prior to the day of the trial by email or regular mail.

### Jump Height Order

Classes with jump heights will run tall to small.

Every effort will be made to accommodate handlers with multiple dogs in the same class.

#### **Notice to Exhibitors**

- SHOW SITE will be available from 7:00 AM to 8:00 PM on Saturday and 7:00 AM to show close on Sunday.
- NO OVERNIGHT PARKING and NO RV PARKING will be permitted in the parking lot due to limited space.
- NORTH ST. LOUIS COUNTY OTC, its members and Westinn Kennels assume no responsibility for loss, theft, damage, or injury sustained by an exhibitor, handler, or any of their dogs or property and further assume no responsibility for injury to children.
- EXHIBITORS should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- AN AKC RECORDING FEE of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single-entry class at any Licensed or Member Club Obedience Trial. (American Kennel Club Rule, Chapter 11 Section 2). These fees are paid to the American Kennel Club.
- ALL ENTRIES must be submitted on official AKC entry forms, one dog per entry form.
- CHANGES, ADDITIONS OR CORRECTIONS to entries must be received in writing or by email prior to close of entries.
- CHECKS for withdrawn entries will be shredded. No check will be returned.
- CONDITIONAL ENTRIES. No entry shall be made, and no entry accepted which specifies any condition as to its acceptance.
- NO ENTRY FEE WILL BE REFUNDED in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.
- NO ENTRY FEE WILL BE REFUNDED if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause which is beyond the control of the Club or the Trial Secretary.
- RETURNED CHECKS do not constitute valid entry fees.
- BITCHES COMING INTO SEASON after close will receive a full refund of their entry fee less \$5 provided that the trial secretary is notified prior to the start of the trial and written verification is provided by a veterinarian.
- ILL OR INJURED DOG OR HANDLER will receive a refund of all but \$10 of the entry fee per trial. A written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian or doctor's letter must be provided.
- DOGS MUST BE READY FOR JUDGING WHEN CALLED TO THE RING. Neither the club nor any ring steward will be obliged to call or notify exhibitors of when they are due in the ring for judging. Judges are not required to wait for any dog.
- ALL CELL PHONES must be turned OFF when in the show building except the emergency cell phone located at the secretary's table, 314-954-5951.
- NCOTC reserves the right to substitute prizes of equal or greater value.
- NCOTC DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FOR ON THE OFFICIAL AKC ENTRY FORM FORM FOR THIS EVENT.

#### **Westinn Kennel Rules**

By entering this facility, I hereby waive, release, and discharge any and all claims for personal injury and/or property damage which I may have or which I may subsequently have against WESTINN, Inc., its officers, and/or any other person associated with WESTINN, Inc. as a result of my use of the property. I understand that my dog and I use the property at my own risk and that WESTINN, Inc., its officers, and/or any other person associated with WESTINN, Inc. are not liable for any accident and/or injury that may arise from said training. This release is intended to discharge WESTINN, Inc., its officers, and/or any other person associated with WESTINN, Inc and their agents from and against any and all liability arising out of or in any way connected with such activities, even though that liability may arise allegedly or actually from any actions whatsoever of WESTINN, Inc. or persons or entities acting on its behalf.

#### Damage to or Loss of Property to Renter and Participants:

During the course of the event, WESTINN, Inc. is not responsible for damage to or loss of property owned by the Renter and Participants whole on the premises and adjacent areas. Renter and Participants are responsible for taking prudent steps to safeguard their personal property during the Event.

#### Aggressive Dogs:

To foster a safe environment, aggressive dogs that are not controlled or controllable will be banned from the premises at the sole discretion of WESTINN, Inc. management and associated instructors. If a Participant's dog tends to be aggressive, he/she is responsible for notifying others and taking all prudent steps to prevent an incident, including voluntarily leaving the premises.

#### Dogs On Leash:

All dogs must remain on leash when on the premises or within the adjoining area, unless working within a designated training or showing area.

#### **Dependents:**

Anyone ages 8-17 years participating in an Event must have a parent or responsible adult in attendance at all times. Disabled dependents and children under 8 years of age must be accompanied by a responsible non-participating adult. NO CHILDREN (OF ANY AGE) OR DISABLED DEPENDENTS ARE ALLOWED TO PLAY OR LOITER IN THE AREAS OUTSIDE OF THE WESTINN BUILDING. Patrons who do not supervise the children in their care or who fail to observe these policies will be banned from the premises. If the Patron's children or dependents tend to pose a risk to themselves or others, or if their behavior is distracting to others and their dogs, they should not be brought to WESTINN or the adjacent parking area.

Fees are as follows if your dog has an accident on the turf at Westinn:


- \$20 for urination
