Every effort will be made to accommodate handlers with multiple dogs in the same class.

Transfers

Transfers will be allowed according to AKC Regulations, provided that the written request is received at least 30 minutes prior to the start of the trial.

Waiting List

This trial will have a waiting list in the event the limits are reached prior to closing.

Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Notice to Exhibitors

- *SHOW SITE will be available from 7:00 AM to 30 minutes after the trial ends on Friday and Saturday and 7:00 AM to show close on Sunday.
- *NO OVERNIGHT PARKING and NO RV PARKING will be permitted in the parking lot due to limited space.
- *NORTH ST. LOUIS COUNTY OTC, its members and Westinn Kennels assume no responsibility for loss, theft, damage or injury sustained by an exhibitor, handler, or any of their dogs or property and further assume no responsibility for injury to children.
- *EXHIBITORS should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- ***Missouri state law** requires all dogs participating in dog shows be free of clinical signs of infectious or contagious disease and must be vaccinated for rabies; dogs traveling from outside of the state are also required to have a certificate of veterinary inspection.
- *AN AKC RECORDING FEE of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Obedience Trial. (American Kennel Club Rule, Chapter 11 Section 2). These fees are paid to the American Kennel Club.
- *ALL ENTRIES must be submitted on official AKC entry forms, one dog per entry form.
- *CHANGES, ADDITIONS OR CORRECTIONS to entries must be received in writing or by email prior to close of entries.
- *CHECKS for withdrawn entries will be shredded. No check will be returned.
- *CONDITIONAL ENTRIES. No entry shall be made, and no entry accepted which specifies any condition as to its acceptance.
- *NO ENTRY FEE WILL BE REFUNDED in the event that a dog is absent, disqualified, excused by veterinarian or judge or barred from competition by action of the Show Committee.
- *NO ENTRY FEE WILL BE REFUNDED if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an act of God, public emergency, act of a public enemy, strikes or any other cause which is beyond the control of the Club or the Trial Secretary.
- *RETURNED CHECKS do not constitute valid entry fees. There is a \$25 return check fee.
- *OVERPAYMENTS of less than \$10 will not be refunded.
- *Since bitches in season are not allowed to compete in AKC Obedience or Rally Trials, the club will refund all but \$5.00 of the entry fee per day for bitches unable to compete for that reason, provided that the trial secretary is notified prior to the start of the trial and written verification is provided by a veterinarian.
- *DOGS MUST BE READY FOR JUDGING WHEN CALLED TO THE RING. Neither the club nor any ring steward will be obliged to call or notify exhibitors of when they are due in the ring for judging. Judges are not required to wait for any dog.
- *NCOTC reserves the right to substitute prizes of equal or greater value.
- *NCOTC DOES NOT AGREE TO ARBITRATE CLAIMS AS SET FORTH ON THE OFFICIAL AKC ENTRY FORM FOR THIS EVENT.
- *IF AN EMAIL ADDRESS IS PROVIDED by the owner or agent on the entry form, a notification of the entry receipt will be sent.

Westinn Kennel Turf Fees:

Fees are as follows if your dog has an accident on the turf at Westinn:

- \$30 for urination
- \$20 for defecation
- \$50 for diarrhea/vomit/blood

Handlers will be responsible for these fines.

Damage to or Loss of Property to Renter and Participants:

During the course of the event, WESTINN, Inc. is not responsible for damage to or loss of property owned by the Renter and Participants whole on the premises and adjacent areas. Renter and Participants are responsible for taking prudent steps to safeguard their personal property during the Event.

Aggressive Dogs:

To foster a safe environment, aggressive dogs that are not controlled or controllable will be banned from the premises at the sole discretion of WESTINN, Inc. management and associated instructors. If a Participant's dog tends to be aggressive, he/she is responsible for notifying others and taking all prudent steps to prevent an incident, including voluntarily leaving the premises.

Dogs On Leash:

All dogs must remain on leash when on the premises or within the adjoining area, unless working within a designated training or showing area.

Dependents:

Anyone ages 8-17 years participating in an Event must have a parent or responsible adult in attendance at all times. Disabled dependents and children under 8 years of age must be accompanied by a responsible nonparticipating adult. NO CHILDREN (OF ANY AGE) OR DISABLED DEPENDENTS ARE ALLOWED TO PLAY OR LOITER IN THE AREAS OUTSIDE OF THE WESTINN BUILDING. From the East: I-70 West to Exit 208. Turn left at the end of the ramp, then cross bridge and at light turn right onto the South Service Road. Turn Left on Swantnerville Dr. (0.5 mi, at First Bank Sign). WestInn Kennel is 500 feet down on the left.

Motel & RV Information

All exhibitors must be responsible for cleaning up after their dogs on the motel, RV and trial grounds. Motels require that dogs be crated when unattended. Any damages to motels, RV sites or the trial site can result in disciplinary action by the Event Committee. It is expected that exhibitors will clean up immediately after their own dogs and strongly encourage others to do the same.

All owners/exhibitors should be aware that the entire motel grounds and RV sites are considered within the trial grounds. You will be responsible for all damage to your room/site and may be subject to disciplinary action in accordance with the rules of the AKC. Any abuse of the grounds will be brought to the attention of the trial-giving club and its Event Committee. Any exhibitor's entries may be refused for previous misuse of the motel or RV facilities. This is an AKC supported measure.

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety your are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color); Beagles (not exceeding 13 inches, over 13 in., but not exceeding 15 in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles); Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name. State on entry form whether transfer application has been made to AKC. (For complete rules, refer to Chapter 11, Section 3.)
