ENTRIES WILL NOT BE ACCEPTED without fees, signatures and the "AGREEMENT" attached to the entry form. Paper entries received within the first 24 hours must include postage or be metered. Entries must be delivered by multi-national postal or carrier service, including but not limited to USPS, FedEx, UPS, and DHL. You must waive the signature requirement for delivery services, if applicable. No FAX entries accepted.

Limit of 10 dogs per envelope

All entries must be submitted on official AKC Obedience/Rally entry forms, one dog per entry form and entries must include a signed copy of the GUIDELINES FOR THE NCOTC SHOW.

Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

Dogs Eligible to Enter

This trial is open to all dogs six (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the AKC Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate. Wherever the word "dog" is used in these regulations, it includes both sexes.

Jump Height Order

Jump height order will be decided after closing.

Every effort will be made to accommodate handlers with multiple dogs in the same class.

Notice to Exhibitors

- *SHOW SITE will be available from 7:00 AM to 8:00 PM on Friday and Saturday and 7:00 AM to show close on Sunday.
- *NO OVERNIGHT PARKING and NO RV PARKING will be permitted in the parking lot due to limited space.
- *NORTH ST. LOUIS COUNTY OTC, its members and Westinn Kennels assume no responsibility for loss, theft, damage or injury sustained by an exhibitor, handler, or any of their dogs or property and further assume no responsibility for injury to children.
- *EXHIBITORS should follow their veterinarian's recommendations to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- *AN AKC RECORDING FEE of 50 cents for each dog and an AKC Event Service Fee of \$3.00 will be required for each recordable single entry class at any Licensed or Member Club Obedience Trial. (American Kennel Club rule, Chapter 11 Section 2). These fees are paid to the American Kennel Club
- *ALL ENTRIES must be submitted on official AKC entry forms, one dog per entry form.
- *CHANGES, ADDITIONS OR CORRECTIONS to entries must be received in writing or by email prior to closing date.
- *CHECKS for withdrawn entries will be shredded. No check will be returned.
- *No entry shall be made and no entry accepted which specifies any condition as to its acceptance.
- *NO ENTRY FEE WILL BE REFUNDED in the event a dog is absent, disqualified, excused by veterinarian or judge or or barred from competition by action of the Show Committee.
- *NO ENTRY FEE WILL BE REFUNDED if the Show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, and act of God, public emergency, act of public enemy, strikes or any other cause which is beyond the control of the Club or Trial Secretary.
- *RETURNED CHECKS do not constitute valid entry fees.
- *BITCHES IN SEASON. The club will refund all but \$5 of the entry fee per trial for bitches in season provided the Trial Secretary is notified in writing at least 30 minutes prior to the start of the trial and written verification is provided by a veterinarian.
- *The club will refund all but \$10 of the entry fee per trial for ill/injured dogs or handlers. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day, and a veterinarian's or doctor's letter must be provided.
- *The club will also refund all but \$10 of the entry fee per trial for handlers who think they may have COVID-19. You must contact the Trial Secretary by email at least 30 minutes before the start of the day. No doctors note needed. If you are sick - PLEASE stay home.
- *Dogs must be ready for judging when called to the ring. Neither the club nor ring steward will be obliged to call or notify exhibitors of when they are due in the ring for judging. Judges are not required to wait for any dog.
- *NCOTC reserves the right to substitute prizes of equal or greater value.
- *NCOTC Does not agree to arbitrate claims as set forth on the Official AKC ENTRY FORM for this event.

INSTRUCTIONS

- (Variety) If you are entering a dog of a breed in which there are varieties for show purposes, please designate the particular variety your are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color); Beagles (not exceeding 13 inches, over 13 in., but not exceeding 15 in.); Dachshunds (longhaired, smooth, wirehaired); Collies (rough, smooth); Bull Terriers (colored, white); Manchester Terriers (standard, toy); Chihuahuas (smooth coat, long coat); English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles); Poodles (toy, miniature, standard).
- The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- A dog must be entered in the name of the person who actually owned it at the time entries for a show closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any show for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
