Notice to Exhibitors

- The <u>safety of the dogs</u> is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.
- <u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused or barred from competition by action of the Event Committee or the judge.
- The clubs may cancel this event in extreme weather conditions.
- <u>Entry fees will not be refunded</u> if the trial cannot be opened or completed by reason of riots, civil disturbance, fire, an Act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the Event Committee.
- Since <u>bitches in season</u> are not allowed to compete in this trial the clubs will refund all but \$5.00 of the entry fee per day for bitches unable to compete for this reason. The Trial Secretary must receive <u>written notification</u> of such a claim for refund by letter hand-delivered, emailed, or postmarked <u>before the trial commences</u>.
- The clubs will refund all but \$10.00 of the entry fee per day for <u>injured or ill dogs</u>. Written request for a refund must be made to the Trial Secretary prior to the start of the first trial day and a veterinarian's letter must be provided within one week of the trial.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case no refund of any fees paid will be made.
- <u>All dogs must be on leash or crated</u> at all times except when in the ring or when in the designated agility warmup area.
- Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. The clubs have no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required. If dogs are not checked in before the end of their jump height walk through, dog & handler team may be marked absent. Failure to be at ring gate could result in the exhibitor being marked absent.
- Entries must be made on Official AKC Entry Forms or copies <u>and must include the signed Agreement and Rules</u>. <u>Junior Handlers</u> must enter their JH# and complete back of form.

Include only AKC titles on form

<u>Owners are responsible for errors in making out entry forms</u>, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date.

<u>Errors in entries made by the exhibitor cannot be corrected after the closing date</u>. No refunds for duplicate The clubs do not agree to arbitrate claims as set forth on the Official AKC entry form for this event.

Returned checks do not constitute a valid entry fee. There is a \$10 returned check fee.

No refunds will be issued for overpayment of less than \$12.

No checks will be returned if an entry is cancelled. Checks will be shredded.

- Exhibitors are responsible for cleaning up after their dog(s) at the show site as well as hotel sites. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- All rights to televise, videotape, advertise, photograph, promote or otherwise exploit this event are vested with the clubs, or persons to whom the assignments of such rights have been made in writing by the Clubs. Photographs and/or video recordings taken for any reason other than personal use are strictly prohibited.

<u>Dogs under 4 months</u> of age are not permitted on the show grounds of AKC Agility Trials.

No Solicitation permitted on the trial site.

Electronic timing will be used at these trials

No un-entered dogs are permitted within 30' of the ring barriers.

No laser lights to be used within 150' of the ring.

Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind or deaf, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the AKC Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

Height Divisions

Owners are responsible for entering their dogs in the proper height divisions. Judge reserves the right to measure dogs entered in the trial. Height divisions are as follows:

AKC Jump Height Cards

All dogs competing in agility must possess an official AKC Jump Height Card. An official AKC Jump Height Card is defined as either a permanent jump height card, a valid temporary jump height form, copies of two different measuring forms (placing the dog in the same height class) dated on or after the dog's second birthday, or copies of three different measuring forms (two of which place the dog in the same height class) on or after the dog's second birthday. All dogs except those jumping 24" or 26" without jump height cards/forms must be measured/wicketed by the Judge of Record PRIOR to running in their class; this measurement will be valid for the weekend of trials only. If a Volunteer Measuring Official or an Agility Field Rep is present, all dogs without a valid jump height card/form must be measured at some time during the trial. If the dog cannot be measured by the VMO prior to running, it must be measured by the judge before its first run. You are not required to show your height card or send a copy with your entry. You must waive the signature requirement for delivery services, if applicable. No FAX entries accepted.

Limit of 10 dogs per envelope

All entries must be submitted on official AKC Agility entry forms, one dog per entry form. Photocopies of entry forms without the AKC Agreement are not acceptable. Unsigned, incomplete, or illegible entries are not acceptable.

If you would like confirmation that your entry was received before the trial has closed, please include your email address or enclose a self-addressed stamped postcard.

Entries cannot be changed once the trial has closed. Please check your entries.

Move-Ups

For the Friday October 29 trial: MOVE-UPS close at 6:00 pm CT, Monday, October 25, 2021. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification had been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial.

After-Closing Wait List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on October 13, 2021. The waiting list will be active until its deadline –Monday, October 25, 2021 at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. If a run is pulled but cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the runs. Entry fees for dogs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Class Description

Obstacles

Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials. All contacts are rubberized.

Prizes and Awards

Rosettes will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement ribbons.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A <u>separate entry form must be submitted</u> when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

As of January 1, 2020, Fix and Go On will be offered on a one-year pilot basis in order to give AKC time to evaluate its impact. FNG allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle and then finish the course or leave the ring on a positive note. Using FNG will result in a non-qualifying score.

Fix and Go On is not pre-entered; rather, it occurs during the course of the run.

For Exhibition Only (FEO)

For Exhibition Only will Not be offered at this trial.

Guidelines for Tri County Agility Club Trials to be held in the fall of 2021

Please bear with us as some of these may change as the trial gets closer. We will keep exhibitors (this is the same as handler) updated if we make changes.

- Everyone MUST wear a mask when in the building. Including in rings while running. Please make sure it covers your mouth and nose. Club will re-evaluate in the ring before closing.
- Two people in the bathrooms at a time. Please wait outside the bathrooms if two people are in the bathroom.
- Gate steward will be set up near the ring entrance. They will be the only ones that can touch the pen. Please do not go past barriers set up around gate steward, timer and scribe. This is their area.
- 4. Running orders will be posted around the building. Please use these to find where you are in the running order. Do NOT hover around the gate steward. You will need to be in line at least 3 dogs ahead of when you run.
- 5. Ribbons will be placed out on the table. Only touch YOUR ribbons.
- **6.** Please still social distance as much as possible in the building.
- 7. Judge and secretary will have a six-foot space around their tables. DO NOT go into that area. This is their safe zone.
- Crating will be spread out as best we can. Chairs will be allowed but there should be at least one crate in between each chair. All chairs need to be next to crates. NO CHAIRS IN AISLES. Crating will be assigned
- 9. NO lunch will be served. The club will order in food for the judge. NO eating except at your chair.
- 10. The club will take everyone's temperature each day when they come in the building, once taken all individuals will be given a wristband to wear for the day. If exhibitors, judges, or volunteers feel sick the morning of the trial, they are asked not to come. We will give a refund for all but \$10 per day if you do not show up because of feeling ill. You will need to email the Trial Secretary ½ hour before the trial starts to receive the refund. If you come to the trial and your temperature is too high you will be requested to leave for the rest of the weekend and will not receive a refund.
- 11. Depending on the current state policy, it will dictate how many people will be in the building at a given time. There will be no outside spectators; only exhibitors and volunteers will be allowed in the building. Only exception will be for handlers under the age of 18 may have an adult accompany them.
- 12. There will be no course maps, we will post them in several locations that are marked. Please do not crowd around the postings. We will have several copies of all maps posted. The will also be posted online the night before.
- 13. All ring crew will use their own chairs. If you volunteer, bring your chair with you.
- 14. Aisles to and from the ring will be marked one way. This is to help with flow of dogs so that reactive dogs do not have to pass each other. All exhibitors need to follow the signs indication the correct direction. Rows will be bi-directional for the handlers crated in those rows. If you are not crated in that row, you should not be in that row.
- 15. Fees are as follows if your dog has an accident on the turf at Westinn:
 - a. \$20 for urination
 - b. \$30 for defecation
 - c. \$50 for loose stool or vomiting

Handlers will be responsible for these fees.

As the exhibitor or guardian of a minor I have read these precautions and will adhere to them. If I do not adhere to the above guidelines, I will forfeit my entry fees and will be asked to leave and not return I understand that I show at my own risk and will not hold the club responsible if I contact COVID-19 or any other virus while showing at these trials. If you have signed the entry form you do not need to sign this since by signing the entry form you have also agreed to the above guidelines and will adhere to them.

INSTRUCTIONS

Handlers may opt to enter in a higher **height division** for all **Regular** titling classes, but not in a division lower than their proper height division. Dogs entered in the **Preferred** classes **must** compete at the required jump height and **may not** compete in a jump height division **higher or lower** than their proper height division.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial *or back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs listed in the AKC Canine PartnersSM program may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
