Dogs Eligible to Enter

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/ Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number, or are approved Foundation Stock Service (FSS) breeds.

Dogs with a PAL/ILP number or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Dogs should be physically sound. Dogs that are blind, bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect a dog's physical or mental performance are not eligible to compete. No dog shall compete if it is taped or bandaged in any way or has anything attached to it for medical purposes. Refer to Chapter 2 of the Rules Applying to Registration and Discipline for the listing of registerable breeds that may participate.

Wherever the word "dog" is used in these regulations, it includes both sexes.

"After Closing" Waiting List

A waiting list (30 run maximum each day) will be maintained for these trials once they have closed on August 10. The waiting list will be active until its deadline - Monday, August 22, at 6:00 pm CT. Any runs that are entered in these trials at closing and pulled before the waiting list deadline will be replaced, if possible, by runs in order on the waiting list, and the exhibitor will be reimbursed in full. **If a run cannot be replaced, the exhibitor will not receive a refund and the dog will be considered absent for the run.** Entry fees for runs on the waiting list that do not get into the trial by the waiting list closing date will be refunded in full.

Height Divisions

Owners are responsible for entering their dogs in the proper height divisions.

AKC Jump Height Cards

All dogs competing in agility must **possess** an official AKC Jump Height Card. **You are not required to show your height card or send a copy with your entry. You are required to mark on your entry form if your dog needs to be measured.** For more information please visit http://www.akc.org/events/agility/jump_height_card.cfm

Move-ups

For the Friday trial: MOVE-UPS close at 6:00 pm CT, Monday, August 22. Move-ups may be sent by regular mail or email to the Trial Secretary. If an email address is provided with your entry, an email confirmation of the move-up will be sent.

For the Saturday and Sunday trials: MOVE-UPS close 30 minutes after the end of the trial on Friday and Saturday respectively and must be submitted at the trial.

Mailed/emailed move-ups close at 6:00 pm CT, Monday, August 22.

Change of Entry

As described in Chapter 1, Section 21 of the Regulations for Agility Trials, a dog which is entered in a Novice A class for which it is not eligible may be moved to Novice B. In addition, if notification has been received in writing from the AKC after closing that a dog is not eligible for a class entered, the dog may be moved to the correct class. The request for the move must be made at least 30 minutes prior to the start of the trial. If a VMO or Field Representative at a trial measures a dog into a height other than what they entered, the entry may be changed from Regular to Preferred or from Preferred to Regular, as long as the dog has not run any classes that day. If the dog has already run, the change may be made for the next trial day(s). The exhibitor must provide the Trial Secretary the AKC Agility Measurement Form when requesting the class change.

COVID Information and Guidelines

The club will follow all current CDC and local Guidelines for COVID safety.

Trial Information

- Trial hours are 7:00 am to 30 minutes after completion of the trial.
- The building is climate-controlled.
- Dogs may not be left in the building overnight.
- Electronic timing will be used at these trials.
- Setup time will be announced after closing.

Notice to Exhibitors

- The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are familiar with and able to perform all obstacles safely.

- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Event Committee.
- Triune Agility Club of SW Illinois may cancel this event in extreme weather conditions.
- Entry fees will not be refunded if the trials cannot be open or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of public enemy, or any other cause beyond the control of the organizing committee.
- Since bitches in season are not allowed to compete in AKC Agility Trials, the club will refund all but \$15 of the entry fee per day for bitches unable to compete for that reason. The club will refund all but \$15 of the entry fee per day for injured dogs. In both cases, written request for a refund must be made to the Trial Secretary no less than 30 minutes before the start of the first day and a veterinarian's letter must be provided.
- People who are experiencing COVID-related symptoms, are self-quarantining, or are involved in contact tracing for COVID exposure will be given a refund less \$15 per day in the form of a voucher to a future trial. To receive a refund, you must contact the Trial Secretary 30 minutes before the trial begins. No doctor's note is required. Any runs for the remainder of the weekend will also be pulled. Please, stay home and keep everyone safe. People who are visibly sick and attend the trial may be asked to leave with NO REFUND.
- The club will refund all but \$15 of the entry fee per day in the form of a voucher to a future trial for injured handlers. A doctor's note must be provided.
- It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children cause unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the trial site. In such case, no refund will be made.
- All dogs must be on leash or crated at all times except when in the ring or when in the designated agility warm-up area. Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Triune Agility Club of SW Illinois has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.
- Entries must be made on Official AKC entry forms or copies, and must include the signed Agreement and Rules. Junior Handlers must enter their JH# and complete back of form. - All owners of mixed breed dogs must first obtain an AKC Canine Partners listing number before they may enter an AKC Agility event. The dog's breed name should be entered as "All American Dog". The dog's listing number must be entered on the entry form and "AKC" No. checked.
- Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. No refunds for duplicate entries.
- Dogs under 4 months of age are not permitted on the show grounds of AKC Agility Trials.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites and any communicable diseases and have appropriate vaccinations.
- Triune Agility Club of Southwest Illinois does not agree to arbitrate claims as set forth on the Official AKC entry form for this event.
- Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.
- No refunds will be issued for overpayment of less than \$10.
- Checks for canceled or unacceptable entries will be shredded. No check will be returned.
- Flexi-Leads are not allowed in the building. X-pens are not allowed in the building.
- Exhibitors are responsible for cleaning up after their dogs. Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement.
- All exhibitors are required to observe the policies of the Triune Canine Training and Event Center. The policies are published at <http://triunecaine.com/event-center/policies/>.

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend

Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers With Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A **separate entry form must be submitted** when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Fix and Go On (FNG)

Fix and Go On allows exhibitors to immediately reattempt an obstacle at any time while on course when the dog's performance of an obstacle is not to their expectation. This allows the dog to successfully complete the obstacle then finish the course or leave the ring on a positive note. Using Fix and Go On will result in a non-qualifying score. Fix and Go On is not pre-entered; rather, it occurs during the run.

Prizes and Awards

Ribbons will be awarded to First Place through Fourth Place in each jump height in each class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Dogs must qualify to receive placement rosettes.

- 1st place Blue
- 2nd place Red
- 3rd place Yellow
- 4th place White
- Qualifying Green

An AGCH Rosette will be awarded to any dog finishing an AGCH at these trials. A MACH bar and rosette will be awarded to any dog finishing a MACH title at these trials. A PACH bar and rosette will be awarded to any dog finishing a PACH title at these trials. A new title rosette will be awarded to any dog finishing a title at these trials. Dogs qualifying in both Master Standard and Master JWW in the same trial will receive a "Double-Q" award (value \$3.00-\$3.85). Dogs qualifying in Master Standard, Master JWW and Master FAST in the same trial will receive a "Triple-Q" award (value \$7.00).

Crate & Chair Information

Please bring crates for your dogs and a chair for yourself.

Ground Covers (ie, tarps, crate mates, towels) are required under all crates. For the safety of everyone, all covers must be completely under your crates.

Food

Food will not be available at the trial site. There are restaurants nearby, and many deliver. Food may be brought into the building and you may eat at your crate space.
