Hino Motors Ltd, HINO SA and Toyota SA Motors and its subsidiary companies (herein after together referred to as "HINO") warrant to the owner of each Hino vehicle that the vehicle including all genuine accessories, chassis and parts (excepts tyres and batteries) manufactured or assembled by "Hino" and delivered to the original retail purchaser by an authorized Hino distributor or dealer to be free under normal use and service from defects in material and workmanship for a period of 12 months/unlimited kilometers.

Hino 300 and Hino 500: The driveline warranty is 24 months or 150,000 km whichever occurs first.

Hino 700: The driveline warranty is 24 months or 300,000 km whichever occurs first.

Further the body panels of the cab of this vehicle are covered by a 3 year unlimited kilometer rust perforation warranty. (Excluding load bodies and chassis.)

The obligation under this warranty is limited at the election of "Hino" to repairing or replacing such parts as shall be acknowledged by it to defective in material or workmanship.

The repair or replacement of defective parts under this warranty will be made by any authorized Hino Distributor or Hino Dealer without charge for parts and labour.

If the owner should be traveling or has changed residence during the warranty period, the warranty service will be performed by any Hino Distributor or Hino Dealer.

The provision of this warranty shall not apply to any Hino Vehicle which has been subjected to negligence, misuse, ignorance accident or alteration or which shall have been repaired or serviced outside Hino Distributor's or Hino Dealer's place of business or which has been subjected to any form of competition, nor to normal maintenance services and replacement of service items, nor to the troubles which may arise from use of parts other than genuine Hino parts.

The warranty on paintwork on all vehicle is 12 months with no limit on the distance covered.

Warranty and Service

Owner's Responsibility

Although your vehicle is covered by the year / unlimited kilometer warranty, there are certain maintenance items which are subject to wear and tear or contamination.

The cost involved in adjustment or replacement of these items is the owner's responsibility.

A. MAINTENANCE SERVICES:

1. LUBRICATION:

Extreme temperatures and weather require more frequent lubrication.

At the same time check lubrication and fluid levels, plus doors, locks, weather stripping, throttle and parking brake linkages.

2. ENGINE OIL AND FILTERS:

Change as recommended to prolong engine life and performance.

Note: Use only the specified lubricants and filters as recommended by your local Hino Dealer or updated service bulletin

3. ENGINE TUNE UP AND ELECTRICAL SYSTEMS:

Check and adjust for maximum economy and performance, including globes, sealed beams units and glass.

4. BELT ADJUSTMENTS:

Check and adjust for proper functioning of belt driven engine components.

5. BRAKE AND CLUTCH ADJUSTMENTS:

Linings are subject top wear and replacement.

6. TYRE ROTATION:

Individual driving habits like stops, fast starts, speed and heavy loads, shorten tyre life.

Rotate periodically for uniform wear and longer life.

7. WHEEL ALIGNMENT AND BALANCE:

Adverse road conditions and driving habits cause wheels to be out of alignment and balance.

Correction will give longer life and better road handling.

8. ENGINE COOLANT:

Refer to your local Hino Dealer or the updated service bulleting for the specified coolant additives.

To prevent corrosion and erosion, these must be maintained as recommended.

9. PAINT FINISH, CHROME AND TRIM:

These items are affected by daily wear and exposure.

Proper maintenance and care will prolong their appearance and durability.

10. FUEL SYSTEM CLEANING:

Contaminates can enter the fuel system from external sources.

When this occurs, the fuel system must be cleaned to restore proper performance.

11. RUST PERFORATION:

In order to keep the rust perforation warranty valid, the responsibility lies with the owner to report any rust to his Hino Dealer immediately.

B. REPLACEMENT ITEMS:

1. OIL, FUEL, AND AIR FILTERS:

These should be replaced at recommended intervals in order to properly perform the important function of cleaning the oil and air.

2. WIPER BLADES:

The life of the wiper blades is dependant upon use and climate conditions.

They should be replaced when necessary.

C. The warranty does not cover expenses incurred as a result of normal wear and tear, inspections, adjustments,

the traveling expenses of personnel or towing charges.

Nor does it cover any losses of whatever nature as a result of the vehicle being laid up.

The warranty period is not extended as a result of repairs during the warranty period.

D. TYRES AND BATTERIES:

Suppliers responsibility.

Dealers are responsible to assist customers in the event of any failure.

Replacement Part's Warranty

The obligation under this warranty is limited at the election of Hino to repairing or replacing such parts as shall be acknowledge by it to be defective in material or workmanship.

The repair or replacement of defective parts under warranty will be made by any authorized Hino Distributor or dealer without charge for parts and labour.

In the event of a genuine Hino part being purchased over the counter from any authorized Hino dealer, the obligation under this warranty will then be limited to the replacement or repair of the DEFECTIVE PART free of charge.

The provisions of this warranty shall not apply to any Hino vehicle/part which has been subject to negligence, misuse, ignorance, accident or alteration or which shall have been repaired or serviced outside of an authorized Hino Distributor's or dealer's place of business, or which has been subjected to any form of competition, nor to normal maintenance services and the replacement of service items, nor to problems which nay arise from use of parts other than genuine Hino parts.

This warranty is expressly in lieu of all warranties, expressed or implied, obligatio0n or liabilities of "Hino" and its authorized Hino Distributor or Dealer.
