VPUSBC 23rd Annual Senior City Championship Tournament Rules

1. Participation in the Local Championship Tournament is open to all members in good standing of the Virginia Peninsula USBC (VPUSBC) who are 50 years of age or older as of Dec 7, 2019.
2. Time Preference: Participation date and time preference will be scheduled in order of receipt of tournament entries.
3. Participation: Bowlers entered in the doubles event must also enter in the singles event. Likewise, all singles event entrants must also bowl in the doubles event. Handicap All-Events is optional, which will consist of singles, doubles, and Team Scores. There will be two categories for Singles and All-Events: Open and Women's. Each category will be divided into three age brackets. 1) 50-59 2) 60-69 3) 70 and up
4. **Proper Attire: Shirt or blouse must have sleeves, and no midriff showing. Trousers, skirts, or shorts must come at least halfway to the knee. Bowlers will not be allowed to participate until dressed in proper attire.**
5. Tournament Averages: Entrants will use their average in the following order: 1) Their highest previous winter season VPUSBC yearbook average based on a minimum of (21) games; 2) Their highest previous summer average based on a minimum of (21) games; 3) If bowler has no previous season VPUSBC book average, bowler will use their highest current certified average of (21) games or more as of Nov 29, 2019, 4) All others will bowl with a 230 average. Written verification of the average must be signed by the League Secretary or participant will enter using a 230 average. Last minute substitutes and non-verified averages will be 230. Participant will have 5 days after bowling to submit verification. If verification is not received or post marked within the allotted time, the bowler will bowl with a 230 average. USBC Rule 319a (2) will not apply. USBC Rules 202A, 319a(3) and 319d do apply. Refer to Rule 319e concerning re-rating.
6. Handicap: To the actual score bowled in each series shall be added a handicap of 90% of the difference between the entering average and 230 scratch, using the individual three-game handicap sheet.
7. Prize Money: Prize money will be determined by the number of entries per event. Prize money for the Handicap Division will be paid with handicaps added to actual score. Prize money will be distributed at a ratio of at least one for every ten (1 in 10) entries for Team, Singles and Doubles events. Prize money will be distributed at a ratio of at least one for every twenty (1 in 20) entries for All-Events. A bowler who places first in the All-Events category but has not paid the optional fee is not eligible for the cash prize. In the event of ties, prize money will equally divided. All prize money will be returned 100%, and mailed to the listed Captain within 30 days following the close of the tournament.
8. Order of Bowling: Teams will bowl in the order submitted on the entry form. Doubles will be bowled before singles. Singles/Doubles will be bowled on the same pair of lanes. A substitute in the singles or doubles event must bowl both events for the original entrant. No substitutes will be accepted for All-Events prize list participation when any one event, or portion of event, has been bowled by the original entrant or the substitute. Team Captains may make replacements on the entry by reporting them to the tournament officials prior to the scheduled event. After the start of any series, no changes will be made in the order of bowlers except that the team captain may replace any player by a qualified substitute at any time. USBC Rules 324a and 324b apply.
9. Official Score: The automatic scorer and/or displayed scores will be the official score during a game. The recap sheets will become official after all scores have been recorded and signed by the team Captain, or singles/doubles participants. When automatic scorers are used, only tournament officials or bowling center employees may make scoring changes. Recap sheets will be audited, and obvious errors will be corrected. Protests involving the scores or any other rules must be made before the awarding of tournament prizes. Any scores lost by automatic scorers shall be re-bowled.
10. Lane Assignments: Lane assignments will be determined by the Tournament Manager.
11. The Tournament Manager reserves the right to add additional squads as needed for the tournament.
12. The Tournament Manager's decisions are final. Appeals can be made in writing according to USBC Rule 329b.
13. Returned and/or redeposit checks will be charged all incurred fees.
