68th ANNUAL VIRGINIA PENINSULA USBC OPEN CITY CHAMPIONSHIP TOURNAMENT RULES

- 1. Participation in the Championship Tournament is open to all members who are in good standing of the Virginia Peninsula USBC (VPUSBC).
- 2. Time Preference: Participation date and time preference will be scheduled in order of receipt of tournament entries.
- 3. Participation: Bowlers entered in the doubles event must also enter in the singles event. Likewise, all singles event entrants must also bowl in the doubles event.

 A bowler is not eligible to enter or compete more than once in the doubles and singles events.

 Bowlers may participate on more than one team; however, not more than two on a four-person team may cash more than once (USBC Rule 315). If a bowler participates in more than one team event, the bowler's scores for the first appearance will count toward his/her All-Events total. Team re-entries are permitted providing lanes are available and entry fees have been paid prior to the start of the desired squad. If a bowler wishes to bring in 3 new team members for the team event, such entry will be accepted, providing the bowler was originally scheduled in the tournament before the early deadline date of March 15, 2020. Scratch division is optional in each event.
- 4. Proper Attire: Shirt or blouse must have sleeves, and no midriff showing. Trousers, skirts, or shorts must come at least halfway to the knee. Bowlers will not be allowed to begin participation until dressed in proper attire.
- 5. Tournament Averages: Entrants will use their average in the following order: 1)Their highest previous winter season VPUSBC yearbook certified average based on a minimum of twenty-one (21) games, 2) Their highest summer average based on a minimum of twenty-one (21) games, 3) Highest Bowl.com average with 21 games 4) If bowler has no previous season book average, bowler will use their highest current certified average of twenty-one (21) games or more as of March 1, 2020, written verification of the average must be signed by the League Secretary or participant will enter using a 230 average. 4) All others will bowl with a 230 average. Last minute substitutes and non-verified averages will be 230. Participant will have 5 days after bowling to submit verification. If verification is not received or post marked within the allotted time, the bowler will bowl with a 230 average. USBC Rule 319a (2), 319a (3) will not apply. USBC Rules 202A and 319d DO apply. Refer to rule 319e concerning re-rating. Youth yearbook averages will be accepted for this tournament.
- 6. Handicap: To the actual score bowled in each series shall be added a handicap of 90% of the difference between the entering average and 230 scratch, using the individual three-game handicap sheet.
- 7. Prize Money: Prize money will be determined by the number of entries per event for Handicap and Scratch Divisions. All added prize monies, if any, will be distributed on a pro-rated basis according to the number of entries in each division. *With a minimum of 20 entries, in each category, the advertised prize money for team will be paid. Prize money for the Handicap Division will be paid with handicaps added to actual score. Prize money for the Scratch Division will be paid based on actual scores. Prize money will be distributed at a ratio suitable by the Tournament Manager for Team, Singles and Doubles events. Prize money will be distributed at a ratio suitable by the Tournament Manager for All-Events. A bowler who places first in the All-Events category but has not paid the optional fee is not eligible for the cash prize. In the event of ties, prize money will be equally divided. All prize money will be returned 100%, and mailed to the listed "Captain" within 45 days following the close of the tournament.
- 8. Order of Bowling: Teams will bowl in the order submitted on the entry form. Singles will be bowled before doubles. Singles/Doubles will be bowled on the same pair of lanes. A substitute in the singles or doubles event must bowl both events for the original entrant. No substitutes will be accepted for All-Events prize list participation when any one event, or portion of event, has been bowled by the original entrant or the substitute. Team Captains may make replacements on the entry by reporting them to the tournament officials prior to the scheduled event. After the start of any series, no changes will be made in the order of bowlers except that the team captain may replace any player by a qualified substitute at any time. USBC Rules 324a and 324b apply.
- 9. Official Score: The automatic scorer and/or displayed scores will be the official score during a game. The recap sheets will become official after all scores have been recorded, and they are signed by the team captain, or singles/doubles participants. When automatic scorers are used, only tournament officials or bowling center employees may make scoring changes. Recap sheets will be audited, and obvious errors will be corrected. Protests involving the scores or any other rules must be made before the awarding of tournament prizes according to USBC Rule 329a. Any scores lost by automatic scorers shall be re-bowled.
- 10. Lane Assignments: Lane assignments will be determined by the Tournament Manager.
- 11. The Tournament Manager reserves the right to add additional squads as needed for the tournament.
- 12. The Tournament Manager's decisions are final. Appeals can be made in writing according to USBC Rule 329b.
- 13. Returned and/or redeposit checks will be charged all incurred fees.
