# 57th Annual TOURNAMENT RULES

- 1. USBC Tournament Rules and Regulations will govern the Tournament.
- 2. The tournament is open to bowlers who are members in USBC leagues within the jurisdiction of the VPUSBC and hold or have filed for individual USBC membership for the current season.
- 3. Teams will consist of 4 bowlers. Doubles event will consist of 2 bowlers. If the entrant bowls Doubles, they must bowl Singles and vice versa. The optional Singles Scratch event will be a Virtual Event using the scores from the bowlers handicap singles event.
- 4. All bowlers will bowl 3 games in each event entered. A bowler may enter Singles only once and may sub up to 4 times in the Doubles and Team events in addition to their regular entry. NOTE: Scores from the first Team and/or Doubles event bowled will count towards all events. All substitutes will qualify for All Events provided they bowl in all three events. Absentee score for team per USBC Rule 322B.
- 5. Each entrant will use their highest current 2019-2020 average as of Jan 11, 2019 (minimum of 12 games). Bowlers not having 12 games by Jan 11, 2020, may report at the time of bowling the highest current sanctioned league average, minimum of 12 games, as of the tournament bowling date. If no current average is available by bowling date the 2018-2019 VPUSBC winter book average will be used. If no VPUSBC winter book average is available the 2018 2019 summer average will be used. If no winter or summer book average is available an average of 230 will be used. The Tournament Director must have verification of the average SIGNED BY THE LEAGUE COACH. ALL HANDICAPS WILL BE BASED ON 100% of 230. Coaches/instructors are responsible for the verification and certification of all information on the entry forms. FALSIFICATION OF AVERAGE OR MEMBERSHIP WILL RESULT IN DISQUALIFICATION. Forms not properly completed and signed by an authorized coach/instructor will be returned.
- 6. All entries must be turned in or post marked no later than Feb 22, 2020. When an entry is submitted and the times are not available, the tournament director will notify the submitting coach. Once the schedule is presented to the coaches, the coach will have 24 hrs to contact the tournament director of any changes. Once the entry has been received and the schedule is completed, there will be NO REFUNDS. Ref.USBC Rule 314.
- 7. Teams must bowl in the same order as listed on the entry form. Singles and Doubles must be bowled in the order assigned. Singles and Doubles will be bowled on the same pair of lanes. Substitutes will be allowed to bowl only in the same lineup position as the bowler being replaced. Team Captains must sign the score sheets to verify team lineup.
- 8. All entrants must report 1 hour before scheduled squad time. If any substitutions are made, The Coach or Adult Advisor must report this to the Tournament Committee one hour prior to squad starting time, with verified average of the substitute.
- 9. Any appeal or protest regarding scores or eligibility shall be made within 24 hrs (in writing) after the error or infraction has occurred.
- 10. **Scholarship awards** will be given to a minimum of the first (3) three positions in each division for handicap Team, Singles, Doubles and. All Events. Scholarships for 1 in 10 paid entries will be given for the Optional Scratch Singles in each division. Scholarship amounts will be awarded based on number of entries and funds available.
- 11. VIOLATIONS OF USBC RULES 17A & 17B WILL RESULT IN FORFEITURE OF AFFECTED SCORES AND GAMES, AND POSSIBLE DISQUALIFICATION FROM THE TOURNAMENT. Note: Appropriate dress is required. No open midriff, no pants below the waist, no sleeveless tops, no jogging shorts or short-shorts, and no hats or facsimile thereof. Tournament Director's decisions on dress are final.
- 12. Only youth bowlers participating in the tournament and Tournament Officials will be permitted in the playing area during the tournament.
- 13. There will be no on lane coaching or coaching in the playing area of youth bowlers during tournament play. Coaching is allowed as long as the child comes back onto the carpeted area (outside of the settee/playing area) as long as it does not delay the game or interfere with the player being ready to bowl when it is his/her turn.
- 14. ANY VIOLATION OF THESE RULES COULD CAUSE SUSPENSION AND/OR DISQUALIFICATION FROM FURTHER PARTICIPATION IN THE TOURNAMENT AND OR USBC.
- 15. Decisions made by the Tournament Director regarding rules and appeals shall be final (Rule 329) unless advised within 72 hours in writing to VPUSBC with copies to the Tournament Director.
- 16. Final awards will be presented during each recipient's youth league within two weeks of the tournament end date.
