## VIRGINIA PENINSULA USBC (VPUSBC) 59th ANNUAL YOUTH CITY CHAMPIONSHIP TOURNAMENT RULES

1. Participation in the VPUSBC Youth City Championship Tournament is open to all youth members in good standing of the VPUSBC.
2. Time Preference: Participation date and time preference will be scheduled in order of receipt of tournament entries. (If Applicable)
3. Participation: This is a team only tournament. Optional HDCP singles/doubles and scratch singles/doubles are available for an additional fee as virtual events using scores rolled in the team event. Scratch team is available if all members pay the additional fee to enter. Both doubles partners must pay the optional fee to enter scratch doubles.
4. Tournament Averages: Entrants will use their highest current 2022-2023 VPUSBC certified average as of February 11, 2023 based on a minimum of twelve (12) games. Bowlers not having 12 games or more as of February 11, 2023 may report, at the time of bowling, the highest current certified average (minimum 12 games) as of the tournament start date. If no current average is available by the start of the tournament, the 2021-2022 VPUSBC book average will be used. If no VPUSBC 2021-2022 book average is available, the 2022 summer average will be used. If no winter or summer book average is available, an average of 230 will be used. The Tournament must have verification of the average SIGNED BY THE LEAGUE COACH (A league standing sheet as of the applicable date will be accepted as well). Coaches are responsible for the verification and certification of all information on the entry forms. Falsification of average or membership will result in disqualification.
5. Handicap: The actual score bowled shall add a handicap of $100 \%$ of the difference between the entering average and 230 , using the individual three-game handicap method.
6. Scholarship Award Prizes: Awards will be given to a minimum of the first three (3) handicap teams, additional places will be determined by the number of entries per event. All added prize money, if any, will be distributed on a pro-rated basis according to the number of entries in each event. Prize money for the Handicap Division will be paid with handicaps added to actual score. Prize money will be distributed at least at a ratio of at least one for every ten ( 1 in 10 ) entries. All prize money will be returned $100 \%$, and scholarship certificates mailed to the listed "Coach" within 30 days following the close of the tournament.
7. Order of Bowling: Teams will bowl in the order submitted on the entry form. Team Captains/Coaches may make replacements in the entry by reporting them to tournament officials 30 minutes prior to the scheduled event. After the start of any series, no changes will be made in the order of bowlers except that the team captain/coach may replace any player by a qualified substitute at any time. USBC Rules 324a and 324b apply.
8. Official Score: The automatic scorer and/or displayed scores will be the official score during a game. The recap sheets will become official after all scores have been recorded, and they are signed by the team captain, or singles/doubles participants. Only tournament officials or bowling center employees may make scoring changes. Recap sheets will be audited, and obvious errors will be corrected. Protests involving scores or any other rules must be made before the awarding of tournament prizes according to USBC Rule 329a. Any scores lost by automatic scorers shall be re-bowled.
9. Dress Attire: Shirt/blouse must have sleeves, no midriff showing. Trousers, skirts, shorts must be at least halfway to the knee. Bowlers will not be allowed to participate until dressed in proper attire.
10. Lane Assignments: Lane assignments will be determined by the Tournament Manager.
11. The Tournament Manager reserves the right to add additional squads as needed for the tournament.
12. The Tournament Manager's decisions are final. Appeals can be made in writing according to USBC Rule 329b.
13. Returned and/or redeposit checks will be charged all incurred fees.
