## VIRGINIA PENINSULA USBC (VPUSBC) 59 ${ }^{\text {TH }}$ ANNUAL YOUTH CITY CHAMPIONSHIP TOURNAMENT RULES

1. Participation in the VPUSBC Youth City Championship Tournament is open to all youth bowlers who are members in good standing of the VPUSBC, currently holding or have filed for an individual USBC youth membership for the current season. USBC Tournament Rules and Regulations will govern this above mentioned tournament.
2. This will be a singles only event. The event will consist of two (2) games and the total pins plus handicap will determine the series bowled. Both games will be bowled on the same lane and will not alternate lanes.
3. Each entrant will use their highest current 2022-2023 average as of February 11, 2023 (minimum of $\mathbf{6}$ games). Bowlers that do not have 6 games bowled by February 11, 2023, may report at the time of bowling and will use their highest current sanctioned league average, with a minimum of 6 games, as of the tournament date. If no current average is available by the tournament date, then their 2021-2022 VPUSBC winter book average will be used. If no VPUSBC winter book average is available, then their 2022 summer average will be used. If the bowler does not possess any of the above mentioned averages, then an average of 100 will be used. The Tournament Director must have verification of the average being used, signed by the league coach. All handicaps will be based on $100 \%$ of 150 . Coaches/instructors are responsible for the verification and certification of all information provided on this entry form. FALSIFICATION OF ANY AVERAGES OR MEMBERSHIPS WILL RESULT IN A DISQUALIFICATION. Forms not properly completed and signed by an authorized coach/instructor will be returned.
4. All entries must be turned in or post marked NO LATER THAN February 18, 2023. Once the schedule is presented to the coaches, the coach will have 24 hrs to contact the tournament director of any changes. Once the entry has been received and the schedule is completed, there will be NO REFUNDS. Ref. USBC Rule 314.
5. All entrants must report $\mathbf{1}$ hour prior to their scheduled squad time.
6. Appeals/protests regarding scores or eligibility will be made in writing within 24 hrs of the error/infraction has occurred.
7. Trophies will be presented, at a minimum, to the top three (3) places.
8. VIOLATIONS OF USBC RULES 17A \& 17B WILL RESULT IN A FORFEITURE OF AFFECTED SCORES AND GAMES, AND POSSIBLY A DISQUALIFICATION FROM THE TOURNAMENT.
9. Appropriate dress is required. No open midriff, no pants below the waist, no sleeveless tops, no jogging shorts or shortshorts, and no hats or facsimile thereof. Tournament Director's have the right to remove bowlers if required dress is not met. Tournament Director's decision on dress and appearance is final.
10. Only bowlers participating in the tournament and Tournament Officials will be permitted in pit area during competition.
11. There will be no on lane coaching and/or coaching of bowlers in the pit area during tournament play. Coaching is allowed as long as the bowler comes to the back outside the pit area and that it does not delay the game or interfere with the other bowlers who are ready to bowl when it is his/her turn.

## 12. ANY VIOLATION OF THESE RULES COULD RESULT IN A SUSPENSION AND/OR A POSSIBLE DISQUALIFICATION FROM FURTHER PARTICIPATION IN THE TOURNAMENT AND OR USBC.

13. Decisions made by the Tournament Director regarding rules and appeals shall be final (Rule 329) unless advised within 72 hours in writing to VPUSBC with copies to the Tournament Director.
14. Final awards will be presented at each recipient's youth league within two weeks of the tournament end date.
