Subject: Visits to Cape Haze Resort

If you are planning to visit Cape Haze Resort during the next few weeks, please review this memorandum carefully. In a Travel Advisory issued March 28, 2020, the Centers for Disease Control and Prevention has urged residents of New York, New Jersey, and Connecticut to refrain from non-essential domestic travel for 14 days, effective immediately.

Florida's Governor has issued Executive Order 20-80, which took effect on March 24, 2020 at 12:01 am. The Order directs "all persons whose point of departure originates from outside the State of Florida in an area with substantial community spread, to include the New York Tri-State Area (Connecticut, New Jersey and New York), and entering the State of Florida through airports to isolate or quarantine for a period of 14 days from the time of entry into the State of Florida or the duration of the person's presence in the State of Florida, whichever is shorter."

The Order further provides that all persons subject thereto shall be responsible for all costs associated with their isolation or quarantine, including transportation, lodging, food, medical care and any the expense of all other to sustenance required during the period of isolation or quarantine. The order does not explain how persons in isolation or quarantine are to acquire those necessities; it seems that home delivery would be the only option.

The Order directs the Florida Department of Health to take all steps necessary to ensure the screening and appropriate isolation and quarantine of covered individuals. Please note that such persons include those traveling from <u>any area with substantial community spread</u> outside the State of Florida. In the latest development, persons covered by the Order now include travelers arriving overland from Louisiana. As the virus moves inland from the coasts, so will the areas of community spread.

Please understand that the scope of the Order may be extended at any time with little prior notice, or none at all. EO 20-71, issued March 20, 2020, closed all restaurants in the state with immediate effect. The disruptions we are living with are expanding daily.

It is the recommendation of the Board to potential visitors is that you stay home. Disregard this advice at your own risk. If you insist on making the trip, bring a 14-day supply of everything you will need during your stay with you, because you may not be allowed to leave your unit. You will not be allowed to use the pool, fitness room, tennis courts or other amenities at the resort during the quarantine period. There are supply shortages here, and stores have shortened their hours. The parks and beaches are closed; restaurants are open for takeout or delivery service only. There is no social activity here.

If you must come, plan your arrival carefully. Make arrangements for access to the property. Please read about the new front gate security system on the website; if you have a code from a previous visit, it will no longer work. Because of the emergency, the

management office is closed, and Cassandra is working from home. If you show up after hours or without a fob, you will not be able to get in.
