If the Company is not permitted by law to deduct the unpaid balance from my final paycheck, I authorize the Company to deduct the next installment payment due. I am aware my employer reserves the right to recover unpaid balances through the cooperation of applicable state agencies. I understand it is my responsibility to return shoes to the Shoes For Crews warehouse if a shoe size change or refund is desired. THIS IS A VOLUNTARY PROGRAM AND IS NOT A CONDITION OF EMPLOYMENT WITH THE COMPANY. VOID WHERE PROHIBITED.
