WHILE WORKING ON THEIR BIKES, STUDENTS ALSO LEARN COMMUNICATION, TEAMWORK, PERSEVERANCE, AND OTHER LIFE SKILLS. JUNIOR EARN A BIKE TEACHES SIMILAR LESSONS TO YOUNGER STUDENTS. UPON COMPLETING THEIR COURSES, STUDENTS EARN THEIR REFURBISHED BIKE AND A NEW HELMET! IN 2018-19, 507 BOYS AND GIRLS PARTICIPATED IN OUR BIKE MENTORING PROGRAMS; 92% EARNED THEIR BIKES.
