ELYRIA USBC TOURNAMENT RULES

1. All entrants must be sanctioned members of the Elyria USBC Bowling Association. If sanctioned in another association, a local only fee of \$14.00 will be required.
2. This tournament is USBC sanctioned and governed by their rules not covered in these tournament rules.
3. Any disputes will be decided by the Elyria USBC Tournament Director(s), and Association Manager.
4. This is a three (3) game handicap women's tournament for singles.
5. Tournament is open to only female bowlers.
6. This tournament has an 80% handicap based on 220.
7. All bowlers are responsible for verifying their own non-composite averages. If any wrong average is used, that bowler can be disqualified with no refund.
8. Entrants will use their highest USBC sanctioned average based on 21 game of the 2024-2025 winter season. If there is no certified average for the 2024-2025 winter season, individuals shall use their highest 2023-2024 certified winter average (21 games or more). If the preceding does not apply, individual will use highest certified average at the time of tournament (12 games most current year). This needs to be signed by their current league secretary. If no previous or current average is available, an assigned average of 220 for women will be used.
9. USBC Rule 319E, 319E2 (10 pin increase in average) does apply.
10. Entry fee is \$35.00 per person, (prize fund \$18.00 /lineage \$12.00, tournament expense \$5.00 per person).
11. A fee of \$35.00 will be assessed for a returned NSF check.
12. Bowlers may need to show their sanction card at the time of check-in.
13. Bowling frames lost by late bowler may not be made up. Rule 322 will apply.
14. Bowlers need to report 30 minutes prior to scheduled time of bowling.
15. No entries fee will be returned after closing date of March 15, 2026.
16. No schedule changes will be made after closing date.
17. Deadline for entries is March 15, 2026. Payment must be received with entry form.
18. If you want to bowl with specific people make it known on the entry form when you turn it in. Otherwise, your lanes will be preassigned.
19. In case of a tie, there will be co-winners.
20. Payout ratio will be 1 out of 5 entries.
21. Payout will occur within 30 days after the close of the tournament.
22. Walk-ins will be accepted if there is lane availability, 30 minutes prior to tournament start time.
23. \$10.00 fee will be accessed for any walk-in bowlers or entries received after the closing date.
