## ELYRIA USBC TOURNAMENT RULES

1. All entrants must be sanctioned members of the Elyria USBC Bowling Association. If sanctioned in another association, a local only fee of \$14.00 will be required.
2. This tournament is USBC sanctioned and governed by their rules not covered in these tournament rules.
3. Any disputes will be decided by the Elyria USBC Tournament Director(s) and Association Manager.
4. This is a three (3) game tournament for singles, doubles, and 4-person team event. It is open to all male, and female bowlers. This tournament has an 80% handicap based on 230 for singles, 460 for doubles, and 920 for team event. There is an optional scratch division buy in for \$10.00 per person per event.
5. Entrants are eligible to bowl more than once in any of the events, but no more than 2 players may compete on the same team more than once. Doubles and singles events must be bowled with a different partner each time. First score in any event bowled counts towards All Events Total Score for any award for this tournament.
6. All bowlers are responsible for verifying their own non-composite averages. If any wrong average is used, that bowler will be disqualified with no refund.
7. Entrants will use their highest USBC sanctioned average based on 21 game of the 2022-2023 winter season. If there is no certified average for the 2022-2023 winter season, individuals shall use their highest 2021-2022 certified winter average (21 games or more). If the preceding does not apply, individual will use highest certified average at the time of tournament (12 games most current year). This needs to be signed by their current league secretary. If no previous or current average is available, an assigned average of 230 for both men/women will be used.
8. USBC Rule 319E, 319E2 (10 pin increase in average) does apply.
9. Entry fee is \$30.00 per person, per event (prize fund \$15.50 /linage \$10.50, tournament expense \$4.00 per person).
10. A fee of \$35.00 will be assessed for a returned NSF check.
11. Bowlers may need to show their sanction card at the time of check-in.
12. Bowling frames lost by late bowler may not be made up. Rule 322 will apply.
13. Walkins will be accepted if there is lane availability. \$10.00 fee per person, per event, will be assessed for any walk-in bowlers or entries received after the closing date. The walk-in cut off time is 30 Minutes Before the event begins.
14. Bowlers need to report 30 minutes prior to scheduled time of bowling.
15. No entries fee will be returned after closing date of March 10, 2024.
16. No schedule changes will be made after closing date.
17. Deadline for entries is March 10, 2024. Payment must be received with entry form. **No partial payments will be accepted.**
18. In case of a tie, there will be co-winners.
19. Payout ratio will be 1 out of 5 entries, for all events, and handicap. Scratch option payout will be 1 out of 10 entries if applicable. Payout will occur within 30 days after the close of the tournament. Bowlers can only cash once in singles and all events at their highest payout level.
