ELYRIA USBC TOURNAMENT RULES

1. All entrants must be sanctioned members of the Elyria USBC Bowling Association.
2. This tournament is USBC sanctioned, and their rules will cover any disputes which are not covered in these tournament rules.
3. This is a three (3) game doubles tournament open to all male and female bowlers. Teams shall consist of 2 men, 2 women or 1 man and 1 woman. This tournament has a 90% handicap based on 460.
4. Entrants are eligible to bowl more than once but can only cash once with the same partner.
5. All bowlers are responsible for verifying their own non-composite averages. If any wrong average is used, that bowler will be disqualified with no refund.
6. Entrants will use their highest USBC sanctioned average based on 21 game of the 2022-2023 winter season. If there is no certified average for the 2022-2023 winter season, individuals shall use their highest 2021-2022 certified winter average (21 games or more). If the preceding does not apply, individual will use highest certified average at the time of tournament (12 games most current year). This needs to be signed by their current league secretary. If no previous or current average is available, an assigned average of 230 for both men/women will be used.
7. USBC Rule 319E, 319E2 (10 pin increase in average) does apply.
8. Entry fee is \$60.00 per team (prize fund \$15.50 lineage/expenses \$14.50 per person).
9. A fee of \$35.00 will be assessed for a returned NSF check.
10. Bowlers may need to show their sanction card at the time of check-in. A driver's license may also be requested to verify an age division tournament if applicable.
11. Bowling frames lost by late bowler may not be made up. Rule 322 will apply.
12. Bowlers need to report 15 minutes prior to the scheduled time of bowling.
13. No entry fee will be returned after closing date of December 25, 2023
14. No schedule changes will be made after the closing date.
15. Deadline for entries is December 25, 2023. Payment must be received with entry form.
16. In case of a tie, there will be co-winners.
17. Payout ratio will be 1 out of 5 entries, per division if applicable. Payout will occur within 14 days after the close of the tournament.
18. Walk-ins will be accepted if there is lane availability. \$20.00 fee per team will be assessed for any walk-in bowlers or entries received after the closing date.
