### ADOPTION OF AGENDA

Gary Vaughn, District Director, reviewed the meeting agenda. The agenda was approved and adopted.

#### ADMINISTRATION MANAGER

Ching Yuan Su, Administration Manager, presented a summary of the July meeting minutes. The meeting minutes and other related documents are available for review by DEC members on the D54 website.

- No corrections were noted.
- Prince Motiani, DTM, motioned for approval, with Sherri Deleonardis, DTM, seconding the motion.

## FINANCE MANAGER

Jason Heissler, Finance Manager, gave the Finance Report. The written report is attached.

- The district reserve account balance is \$23,831.48 as of June 30, 2024.
- The checking account balance is \$2,925.72 as of June 30, 2024.
- Membership revenue for the year exceeded the budget by 9%, while expenses were 64% lower than budgeted. In February, TI is set to reclaim a significant portion of the district's reserve.

- Ten clubs successfully met the officer training goal.
