


Abandoned

Unfortunately, I often hear of cases where owners have walked off and left their horses at a boarding stable. There are laws in each state directing what stable owners must do to get title to a horse. They can't just sell the horse or send it to auction, even if the contract calls for this resolution in the event that board is not paid. Just because you write something in a contract, it does not negate the laws of a state. In this case after all the years of care that had been given to the horse, the laws of adverse possession take care of the issues of ownership, as the past owner never contacted the stable or showed any interest in the horse after abandoning him. I don't understand why people won't give title to a horse to the stable instead of just deserting the horse.

Over the years we have had similar situations arise when real estate agents, new purchasers of property, stable owners, and the general public call to find out what to do with an abandoned horse/s that have been left on a property. We have taken in many such horses. Cree was left in a field and brought to HPS by one of our contributors in July of 2012 and is doing great here at the sanctuary, and we look forward to a similar outcome with Eclipse.

So Easy to Make a Difference


We need all the help we can get to save and build funds and there are some things that you can do that make it easy to help!

Our Christmas Wish for the Horses

Just when we think our construction is over at the sanctuary, a new problem arises. Each year the hay we

purchase has gone up in price while the harvest has decreased. We have gone from \$25.00 per round bale when HPS started to \$50.00 for a round bale last summer. Now it costs \$76.42 per bale to bring in hay from northern Virginia. That covers the cost of the hay at \$48.00 per round bale, \$700.00 for transport of 38 bales (or \$18.42 a bale), and then the unloading and storage fees at \$10.00 a bale.

At these prices, we can't afford to waste one bit of hay. We have discussed the best ways to ensure we're not losing hay to the rain, and the reality is we need another covered hay feeder.



This is a good solution for the horses since they do not share well, and another 44' long, double sided hay feeder provides more feeding room and would be the ideal solution to our problem. The cost will be \$21,500.00 for the feeder and approximately \$5,000.00 for the fill dirt and leveling of the area. This expenditure will ultimately save HPS the loss of hay to the weather while also providing more grass areas to graze, as these areas have been covered by the five to six bales placed out in the fields.

A covered hay feeder also keeps the horses out of the cold weather and storms and gives them shade in the hot summer months. We desperately need this for the good of our rescued horses. Please help HPS build another covered hay feeder. *A donation of any size will be helpful.*
