## Best Laid Plans

Gallant & Chief

It was arduous to learn about the different types of generators and then sort through the companies and all the reviews.

We have had several times when the electricity went off for days, and it was a close call providing water for the horses' needs. Each time we talked of the need for a propane electric generator. We thought we had found a good company and were ready to send the down payment when we learned they were not an approved company by Generac. It was impossible for them to get the generators. Commodity prices have gone up, and our horse feed has increased by 6%.

HPS has an excellent Electrician that we call on when there are issues. We had to have several GFI outlets replaced that run water heaters for the tubs and the electric fence.

January 21<sup>st</sup> we dropped off all of the Tax Notices at the post office, and they are on their way to all the folks who kindly helped with the financial needs of the rescued horses. The February Newsletter will be running late. Everything is late since we had to get the Tax Notices done and mailed.

It was going to possibly take several months to get a new, used tractor that was strong enough to take care of the mud. Chris Morgan worked for several days and has made a big difference. There is still work to be done and rock to be spread.

The last chapter is unbelievable! Saturday, the 23<sup>rd</sup>, early morning, one of the members comes in to report what looks like a rabid raccoon on the property. I called Animal Control, and they were not open. The 911 operator contacted the AC officer that was on duty. She seemed more interested in the COVID virus than the raccoon with rabies. 'Does anyone have the virus or tested positive?' I felt a raccoon with rabies was more important since we have so many people here and animals that could be infected.. I assured her we needed help.

She was going to talk with her supervisor since she didn't know what to do. She called back and told me to call a phone number in Raleigh. I asked for her phone number, knowing this was not going to help. Of course, no one answered, and they wouldn't be open until Monday. I asked if I should call the Sheriff's department (she said, "No"). Should I contact the Health Department? (Once again, she said. "No"). I am upset, to put it mildly! Two things that will make me mad are endangering or cause an issue with our folks here or endanger the horses and other animals.

The first line in the Enforcement page for Rowan Animal Control states: **Animal Enforcement staff is active in rabies control.** Further down the page: **Investigating potentially dangerous and/or rabid animals.** The gal would not come and check this raccoon with rabies out or do anything about this issue. She made every wild excuse possible! I told her, "We would take care of the problem!"

Later speaking with a neighbor, we learned there were two foxes and a raccoon killed in the neighborhood since they also showed signs of rabies. Good luck if you have a rabid animal on your property!

We still need to complete the Newsletter, get the truck inspected, the battery is dead in Little Red, more rock needs to be spread and some fencing needs to be repaired. Sometimes it is just like this around here.



## Ways to Keep Livestock Water from Freezing

At the sanctuary, we had GFI outlets installed on each of the two barns' outside corner. The heaters are safe for the horses, and the GFI outlet keeps them from being electrocuted.

One idea I have read about that is reported to work well is [Cow Balls](#). “These 4-in. diameter black plastic balls float on the water in the tank. The sun heats them up so that they insulate the water in the tank to prevent ice from forming except in extremely cold weather. If ice does form, it does not take much sunshine to rewarm and loosen the balls. Thirsty cows looking for water can usually breakthrough by pushing on the balls with their noses.”



“You have to use enough of the Cow Balls to cover the tank. When people order them, they get the dimensions of the tank where they will use them. They provide enough balls to cover the surface. Cow Balls are meant to remain on the tank year-round. In the summer, the balls reduce evaporation, helping to conserve water. They also help keep algae growth down by limiting the amount of sunlight that enters the water.”

Horses would love the balls in the tank. They would spend time working on taking the Cow Balls out of the tub.

A large barrel painted black supported slightly above the water tank can supply water as needed. The barrel needs to be attached to a float in the water tub. In the summer, the large barrel can be covered to help keep the water cooler. Wrapped the water tub in black plastic for the winter and then remove the plastic in summer.

## New Rule for Showing Your Horse

In 1998, Germany outlawed shaving whiskers. Their Animal Welfare Law prohibits the trimming of vibrissae around eyes and muzzle, as well as clipping or cutting the hairs inside the ears.

FEI passed a new rule covering all disciplines competing internationally under FEI rules. The wording, which was voted on unanimously, states that horses having whiskers/ears clipped are not permitted to compete in FEI events. The new rule reads: “if the horse’s sensory hairs have been clipped and/or shaven or in any other way removed unless individual sensory hairs have been removed by a veterinarian to prevent pain or discomfort for the horse.” France also bans the trimming of whiskers.

You may be shocked to know that a horse’s whiskers (vibrissae) are actually an incredibly important sense to them. The whiskers around the eyes and muzzle are extremely sensitive and have a rich nerve supply. Due to the position of their eyes, horses cannot see under their mouth, and so the whiskers allow them to explore and identify what is under their nose. There are many more reasons not to trim the eyes and muzzle whiskers.

There is finally some conversation about banning the trimming of whiskers and ear hair in the show circuits in the US.

## Protect Your Property

There is a new advertisement on TV called "Title Lock." They are telling people that cyber crooks can steal your home, and your home owners insurance will not cover this. It is true, but what the ad doesn't tell you is that the Title Insurance that should have been paid for at closing does protect you from claims on your property or any easement that was not listed on the policy, etc. It is paid for out of the closing funds and the policy should arrive by mail three to six weeks after buying the property. The policy should be kept with your other closing papers.

When I purchased the property here, the Title Insurance Policy didn't arrive in a timely matter. I called the lawyer that handled closing, I called him again and again and finally months later, I still didn't have the policy. I told him that I would make the calls to the state to report him if I didn't have the policy the next day. I did receive it! Shortly later he lost his license to practice law. Do you think he was pocketing the money and not buying the Title Insurance Policy?

Don't wait, and find your Policy now. If it was lost you can get a reissue of the Policy. It should only take a couple of phone calls..... If it was purchased.
